Our core Public Works and Economic Adjustment Assistance (PWEAA) programs in 2021 supported construction, non-construction, revolving loan fund, and other projects in distressed communities, including those impacted by changes within an industry, such as those reliant on coal production.

In addition, 50 organizations — including nonprofits, institutions of higher education, state government agencies, and other entrepreneurship-focused organizations — from 26 states were provided with \$36.5 million in FY 2021 Build to Scale project funding to fuel innovation and tech-based economic development while our FY 2021 STEM Talent Challenge deployed a total of \$2 million to eight organizations to create and implement STEM talent development strategies that complement their region's innovation economy.

EDA was honored in FY 2021 to take on the awesome responsibility of administering the American Rescue Plan funding to help those communities that are truly in need. We are committed to equitably delivering this critical assistance. I am thankful for the hard work and dedication of our EDA employees. EDA's Mission and Role

The mission of the Economic Development Administration (EDA) is to lead the federal economic development agenda by promoting innovation and competitiveness, preparing American regions for growth and success in the worldwide economy. EDA is the only federal government agency focused exclusively on economic development, and it plays a critical role in facilitating regional economic development efforts in communities across the nation.

Guided by the basic principle that sustainable economic development should be locally-driven, EDA works directly with communities and regions to help them build the capacity for economic development based on local business conditions and needs. EDA's grant investments in planning, technical assistance, and infrastructure construction are designed to leverage existing regional assets to support the implementation of economic development strategies that make it easier for businesses to start and grow. EDA's flexible programs and structure enable nimble operations and allow for innovation and responsiveness to changing economic needs and conditions faced by its local and state government partners.

American Rescue Plan

Under the American Rescue Plan (ARP), EDA was appropriated \$3 billion in supplemental funding to assist communities nationwide in their efforts to build back better by accelerating the economic recovery from the coronavirus pandemic and building local economies that will be resilient to future economic shocks.

American Rescue Plan funding enables EDA to provide larger, more transformational investments across the nation while utilizing its greatest strengths, including flexible funding to support community-led economic development.

With an emphasis on equity, EDA investments made under the American Rescue Plan will directly benefit previously underserved communities impacted by the COVID-19 pandemic. EDA is administering its American Rescue Plan funding through six* programs, collectively called “Investing in America’s Communities.”

* The Coal Communities Commitment uses \$100 million of Build Back Better Regional Challenge funds and \$200 million of Economic Adjustment Assistance funds, to directly support communities impacted by the declining use of coal.

Build Back Better Regional Challenge

Capitalizes on American ingenuity and American workers by providing transformational, cluster-based investments in interconnected firms and supporting organizations to regions across the country to spur new or advance nascent local industries.



Indigenous Communities

Works hand-in-hand with Tribal Governments and Indigenous communities to develop and execute economic development projects they need to recover from the pandemic and build economies for the future.



Travel, Tourism, and Outdoor Recreation

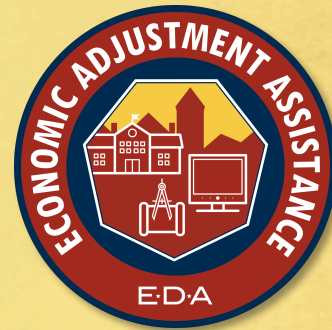
Focuses on revitalizing the hard-hit travel, tourism, and outdoor recreation industries and accelerates the recovery of communities that rely on these sectors.

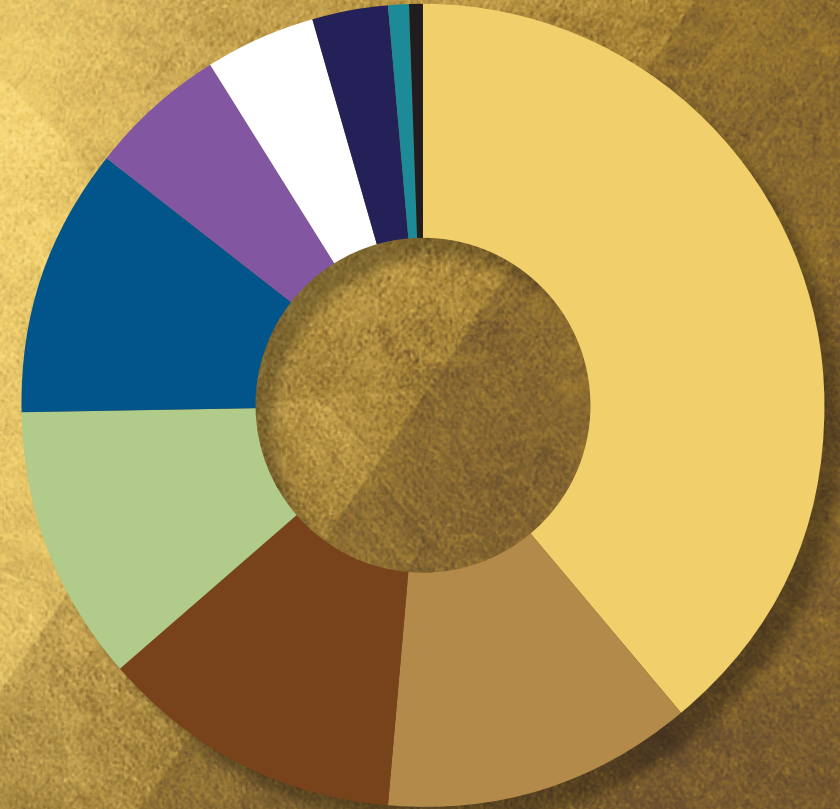

Private Sector Investment Goals

Section 603(b)(2) of the Public Works and Economic Development Act of 1965, as amended, requires EDA to include in its Annual Report to Congress a discussion of private sector leveraging goals set for investments awarded to (a) rural* and urban economically distressed areas; and (b) highly distressed areas.**

* Rural includes investments made in Indigenous tribes.

** For an area to qualify as being highly distressed, one of the following criteria must be met: (a) a 24-month unemployment rate of at least 200 percent of the national average, (b) per capita income not more than 60 percent of the national average, or (c) a catastrophic disaster.

Note: U.S. Department of Defense reimbursable investments and disaster supplemental investments are not included in these calculations.



Private Sector Investment Goals *(continued)*

The following information is provided to respond to those requirements:

- (a) In FY 2021, EDA invested 61% percent of its Public Works (PW) and Economic Adjustment Assistance (EAA) funds, including Revolving Loan Funds (RLF), in rural areas which recipients expect will leverage approximately \$3.4 billion in private investment; 39% percent of the funds were invested in urban areas which recipients expect will leverage close to \$2 billion in private investment.
- (b) In FY 2021, EDA invested 78% of all its PW and EAA funds, including RLFs, in highly distressed areas, which, according to recipient estimates, are projected to generate approximately \$4 billion in private investment.



Notes

The data presented in this report represent the official grant data for awards (organized by applicant state) made by EDA in FY 2021. EDA has verified the data through a reconciliation process, conducted annually, between EDA’s grant management systems and the Department of Commerce’s accounting system.

As such, any previously provided information regarding EDA awards made in FY 2021 should be viewed as a snapshot of the data available at the time of the data request and are subject to any changes, corrections, or updates as reflected within this report. This includes, but is not limited to, revisions to the number, dollar amount, program classification and estimated impacts of specific grant awards.

Projects described within individual state entries are provided as illustrative examples. No project preference should be inferred from these examples. EDA uses this report to demonstrate the breadth and diversity of EDA programs and the projects which it funds.

EDA did not have any investments in FY 2021 to the Republic of Palau or the Republic of the Marshall Islands.

EDA’s level of match under the Public Works and Economic Development Act of 1965 is determined by statute and varies based on the relative level of distress and other factors. EDA can fund 100% of a project in certain circumstances, such as with a tribe or after a Presidentially-declared disaster.



ALABAMA

Recipient: The University of South Alabama (USA)

Title of Project: USA Hospital Emergency Generator Replacement Project

Project Location: Mobile/Mobile County

EDA Investment: \$3,806,761

Local Match and Other Funding Sources: \$951,691

Brief Project Summary: This EDA investment supports the University of South Alabama with installing a new emergency generator system to power the University Hospital in times of a catastrophic power outage or natural disaster in Mobile County, Alabama. The project will assist the region with recovery efforts from Hurricane Michael by providing electrical energy for the entire hospital for an extended period, allowing the hospital to continue to provide medical services in the event of long-term power disruptions created by natural disasters or power company interruptions. The project is expected to retain 1,700 jobs, help mitigate the effects of future disastrous events, promote economic resiliency, and strengthen the regional economy by ensuring the long-term viability and continuous operation of the Central Gulf Coast region's only Level 1 trauma center.



ALASKA

Recipient: Fairbanks Pipeline Training Center Trust

Title of Project: Training Equipment Acquisition Project

Project Location: Fairbanks/Fairbanks North Star County

EDA Investment: \$1,996,160

Local Match and Other Funding Sources: \$499,040

Brief Project Summary: This EDA investment supports the Fairbanks Pipeline Training Center Trust with purchasing heavy-duty equipment to train Alaskans in operation and maintenance in the oil and gas, mining, and major construction industries. The project will better support the growing workforce demand brought to Alaska through the following projects: LNG Pipeline Project; Boeing Missile Silos Donlin Gold Project; the Yukon-Kuskokwim Freight Corridor, Energy Corridor Project; and infrastructure projects conducted in the Bethel and Northwest Arctic Borough in Alaska. The project will help the region with recovery efforts from the coronavirus pandemic by providing apprenticeships to help promote a pipeline of skilled workers. The project is expected to create 1,370 jobs and leverage \$10.5 million in private investment, which will advance economic resiliency throughout the region.



AMERICAN SAMOA

Recipient: American Samoa Government Department of Commerce

Title of Project: Local Fishing Fleet Development Initiative Project

Project Location: Pago Pago/Eastern County

EDA Investment: \$4,377,666

Local Match and Other Funding Sources: \$0

Brief Project Summary: This EDA investment supports the American Samoa Government of Commerce with the purchasing of four small, modern and upgraded traditional-stylized commercial fishing vessels to support the growth of the local fishing fleet in Eastern County, American Samoa. The project will help with recovery efforts from Cyclone Gita by allowing one vessel to function as a training platform while the other three vessels function as business incubators. The project is expected to create 50 jobs and leverage \$2 million in private investment, which will support economic diversification, boost workforce development, and promote a long-term sustainable fresh fish industry throughout the region.

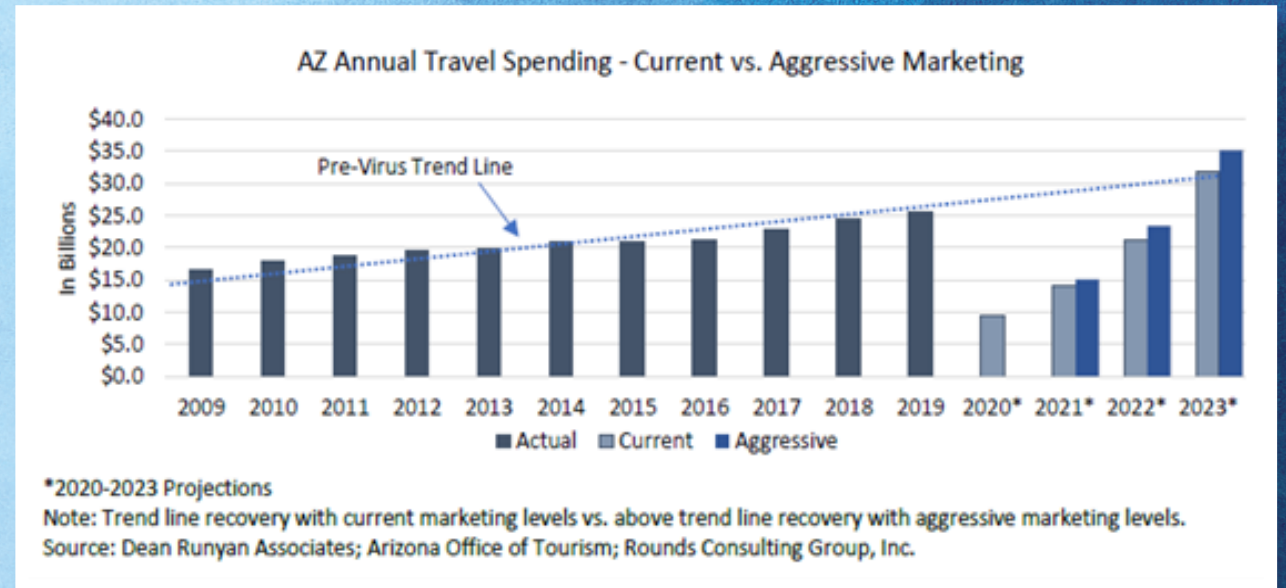
Title of Project: Tourism Marketing Grant Project

Project Location: Phoenix/Maricopa County

EDA Investment: \$2,200,000

Local Match and Other Funding Sources: \$0

Brief Project Summary: This EDA investment supports the Arizona Office of Tourism with the design and implementation of a multi-dimensional marketing campaign to help Arizona recover from record tourism declines due to the economic disaster of the COVID-19 pandemic. The project will recoup lost revenue and jobs by attracting income producing meetings and conventions, creating rural and tribal sustainable tourism development opportunities, and jumpstarting recovery through a data driven marketing campaign that will trigger increases in visitors and visitor spending. The project is expected to create 12,500 jobs, which will help support the local tourism industry and advance economic resiliency throughout the region.

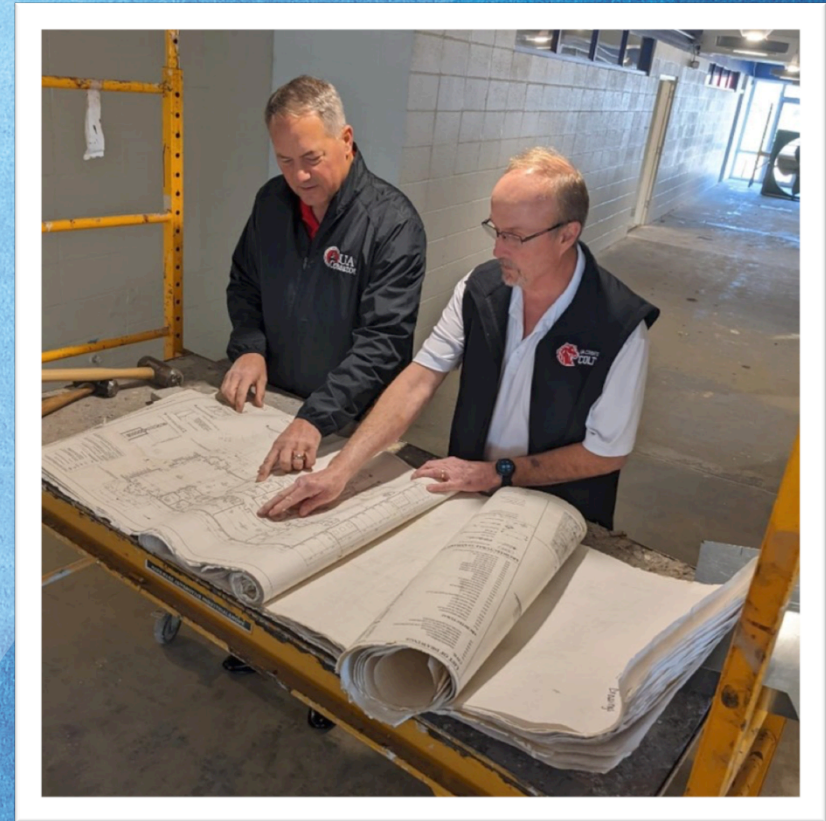
Title of Project: Medical Mobile Unit Project

Project Location: De Queen/Sevier County

EDA Investment: \$2,000,000

Local Match and Other Funding Sources: \$0

Brief Project Summary: This EDA investment supports the purchase of a Medical Mobile Unit to create a Healthcare Simulation Lab and Telemedicine Space at each of University of Arkansas Cossatot's four campus locations. The project will help increase healthcare access and testing for rural community members and industries, as well as provide a safe learning environment for medical education students to receive clinical training. The project is expected to create 105 jobs and leverage \$100 thousand in private investment, which will increase the region's capacity to recover from the coronavirus pandemic, advance long-term economic vitality and sustainability, and strengthen the regional economy.

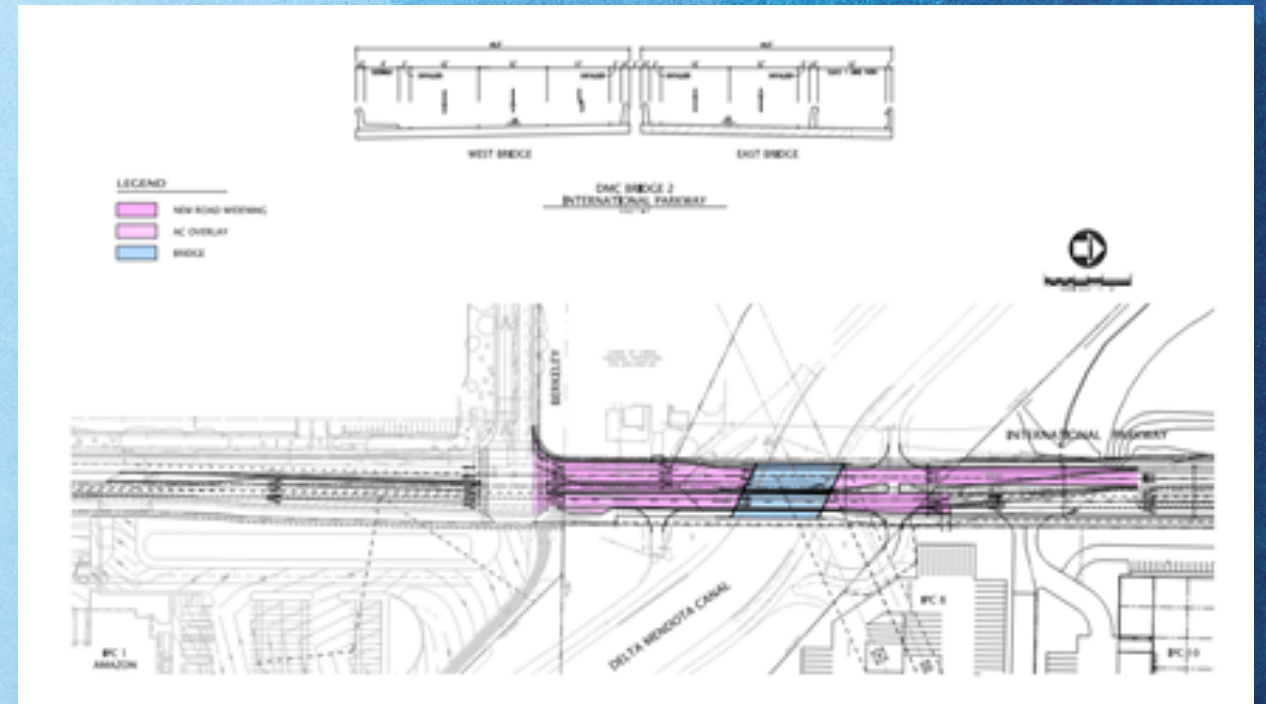
Title of Project: Bridge Expansion Project

Project Location: Tracy/San Joaquin County

EDA Investment: \$8,350,057

Local Match and Other Funding Sources: \$2,087,514

Brief Project Summary: This EDA investment supports the City of Tracy with replacing and expanding the International Parkway Bridge over the Delta Mendota Canal in San Joaquin County, California. The project will relieve a chokepoint and enhance supply chain movement for the industrial park's essential industries to enhance the efficiency of freight movement for existing companies. The project is expected to create 2,145 jobs, save 6,734 jobs, and leverage \$459 million in private investment, which will help the region with recovery efforts from the COVID-19 pandemic and advance economic resiliency throughout the region.



COLORADO

Recipient: Colorado Mesa University

Title of Project: Healthcare Workforce Development Project

Project Location: Grand Junction/Mesa County

EDA Investment: \$1,121,963

Local Match and Other Funding Sources: \$280,495

Brief Project Summary: This EDA investment provides medical and therapeutic equipment, mobile simulation technology, and funding for personnel and programming to Colorado Mesa University (CMU) for a workforce development project in communities in western Colorado. The project will equip CMU's Physician's Assistant, Physical Therapy, and Occupational Therapy degree programs to support academic programming, professional and workforce development activities, and outreach to displaced coal workers and their families. The project will help increase workforce development in healthcare fields, not only through ensuring availability of equipment for specialized training, but also by implementing recruitment strategies that provide exposure and a pathway to health care careers in the University's rural, frontier, and underserved service region. The project is expected to create 210 jobs, which will help provide new job opportunities in areas that has been impacted by the decline in the coal industry.

Title of Project: Connecticut Statewide Recovery Project

Project Location: Hartford/Hartford County

EDA Investment: \$2,033,578

Local Match and Other Funding Sources: \$508,395

Brief Project Summary: This EDA investment supports the State of Connecticut's statewide long-term COVID-19 pandemic economic recovery coordination, resiliency planning, and technical assistance across six regions in Connecticut and technical assistance to businesses throughout the area. The project will also address the State's current economic need by providing educational webinars to assist impacted businesses. The project is expected to strengthen employment and business recovery efforts at the local, state, and regional levels, which will promote economic growth throughout the region.

DELAWARE

Recipient: State of Delaware - Delaware Division of Small Business

Title of Project: Delaware Revolving Loan Fund Project

Project Location: Dover/Kent County

EDA Investment: \$1,500,000

Local Match and Other Funding Sources: \$0

Brief Project Summary: This EDA investment supports the Delaware Division of Small Business with establishing a Revolving Loan Fund (RLF) to provide access to capital for small businesses that suffered economic injury because of the COVID-19 pandemic across the entire State of Delaware. The RLF will provide access to capital through loans with flexible, below market terms that will include waiving the application fees, allowing a minimum of 12 months of forbearance, and giving preference to small businesses that are located in Qualified Opportunity Zones, Certified HUBZones and Delaware's Downtown Development Districts, which were identified as distressed areas even before the pandemic occurred. The project is expected to create 1,500 jobs and save 500 jobs, which will provide permanent resources to further long-term economic adjustment objectives and advance economic resiliency throughout the region.

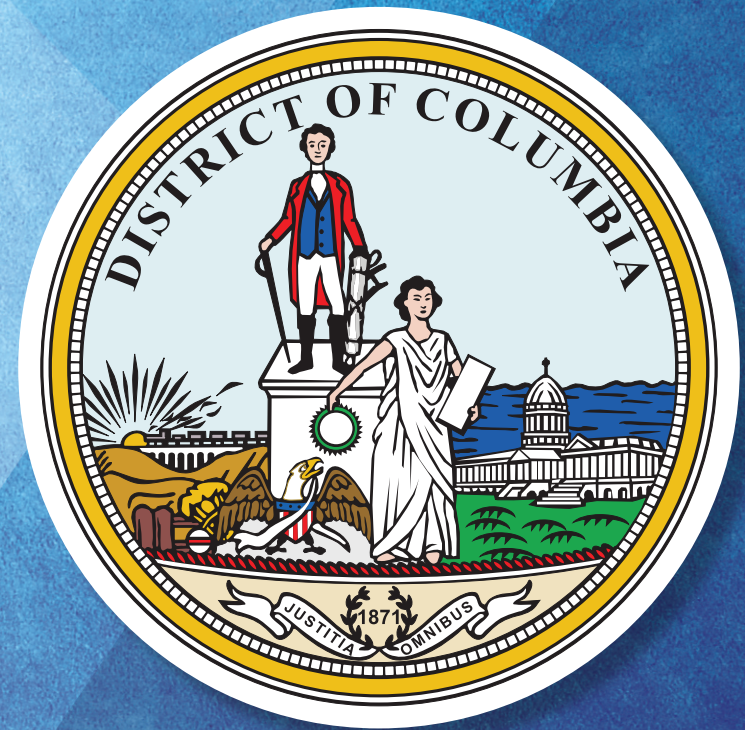
Title of Project: Advancing Economic Development Project

Project Location: Washington, D.C.

EDA Investment: \$500,093

Local Match and Other Funding Sources: \$166,698

Brief Project Summary: This EDA investment funds a cooperative agreement to direct research of a series of case studies with deliverables designed to have a transformative impact on determining and understanding the landscape of persistent poverty in the United States. The geographic, quantitative, and qualitative research will serve as a foundation for stakeholders to develop new and more inclusive economic development models through understanding why certain types of places remain persistently poor and chronically under-developed. The project is expected to explore the question by baselining persistent poverty areas on the foundational building blocks of economic development, decomposing the different forces at work that inhibit development from taking hold, and conducting a series of case studies that explore more qualitatively how the various dynamics come together and how cycles of persistent poverty might be overcome.



FEDERATED STATES OF MICRONESIA

Title of Project: FSM Entrepreneurship Initiative: Phase II Project

Project Location: Pohnpei/Federated States of Micronesia

EDA Investment: \$979,837

Local Match and Other Funding Sources: \$72,494

Brief Project Summary: This EDA investment supports the College of Micronesia-FSM with increasing the region's agricultural production by establishing an entrepreneurship development program in Pohnpei, Micronesia. The project will include the construction of four hydroponic greenhouses, conduct dozens of educational workshops, and provide start-up support through consultation and counseling. The project is expected to create 33 jobs, save 25 jobs, and leverage \$2 million in private investment, which will enhance export ability, educate farmers, foster partnerships to increase food security, and to help the region recover from the COVID-19 pandemic.

Title of Project: Lake City Gateway Airport Improvements Project

Project Location: Lake City/Columbia County

EDA Investment: \$2,296,000

Local Match and Other Funding Sources: \$724,675

Brief Project Summary: This EDA investment supports Lake City with retrofitting Hangar 1 and Hangar 2 at the Lake City Gateway Airport in Columbia County, Florida. The project will help the city absorb, recover from, and adapt to the COVID-19 pandemic and similar disasters by constructing critical infrastructure that promotes economic diversity in the area. The project is expected to create 300 jobs, save 512 jobs, and leverage \$1.2 million in private investment, which will support the aviation industry and advance economic resiliency throughout the region.

Recipient: City of Waynesboro

Title of Project: Water Improvements Project

Project Location: Waynesboro/Burke County

EDA Investment: \$1,474,298

Local Match and Other Funding Sources: \$1,474,299

Brief Project Summary: This EDA investment supports the City of Waynesboro with constructing a water well and water treatment facility that will serve a new dairy processing and packaging plant at the Waynesboro-Burke County Industrial Park, located in a designated Opportunity Zone in Georgia. The project is expected to create 199 jobs and leverage \$60 million in private investment, which will advance the region's manufacturing industry and strengthen the regional economy.

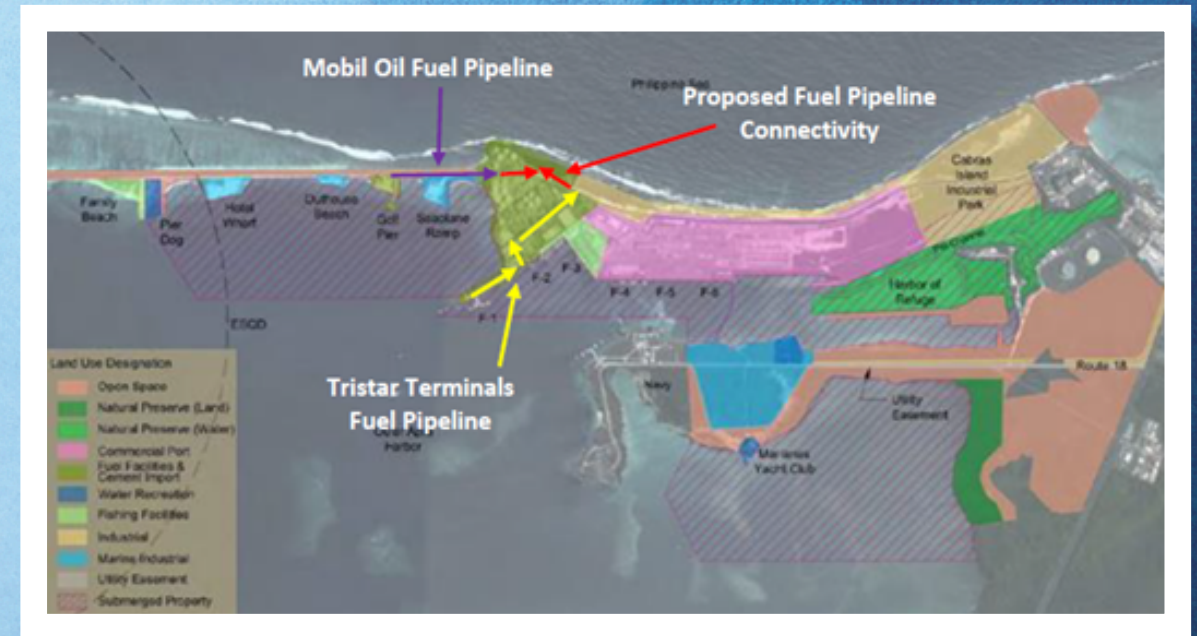
Title of Project: Fuel Pipeline Installation Project

Project Location: Piti/Guam County

EDA Investment: \$2,413,091

Local Match and Other Funding Sources: \$603,272

Brief Project Summary: This EDA investment provides a connection between the Port's F1 and Golf Piers to ensure that bulk fuel, jet fuel, and liquefied petroleum gas distribution and delivery remains uninterrupted for the Island of Guam, in the event that either pier is impacted by natural or man-made incidents. The project supports Guam's existing economic enterprises, which support an estimated 49,000 private sector jobs. Beneficiaries expect the project to create 15 new jobs and save 32 jobs.

Title of Project: Innovation Impact Challenge Initiative Project

Project Location: Honolulu/Honolulu County

EDA Investment: \$2,700,000

Local Match and Other Funding Sources: \$813,068

Brief Project Summary: This EDA investment supports the University of Hawaii with expanding its Innovation Impact Challenge (IIC) Initiative, to include an IIC Technology Development Program and an IIC Workforce Development Program. Once implemented, the new programs will focus on further developing and implementing:

1. A leveraged and strategic commercialization and workforce development pipeline based on Hawaii innovations developed through targeted and deliberate multi-disciplinary collaborations;
2. Programs to provide training for current high-quality jobs and future jobs created by a new diversified economy; and
3. Programs to support local small business, including the development of a global market pipeline for locally developed products. The project is expected to help businesses respond to the COVID-19 pandemic by providing opportunities to re-skill, up-skill and cross-skill Hawaii's workforce, and supporting the creation of new small businesses throughout the state.

Title of Project: North-South Fiber Link Broadband Feasibility Study Project

Project Location: Grangeville/Idaho County

EDA Investment: \$120,000

Local Match and Other Funding Sources: \$30,000

Brief Project Summary: This EDA investment supports a rural broadband feasibility study to explore solutions to economic and community impacts of the COVID-19 pandemic in the state of Idaho. The study will lead to the construction of a fiber link to create the first north-to-south intrastate broadband link throughout Idaho. The intrastate accessibility will increase speed, redundancy, and access statewide. The project is expected to create and retain jobs, improve business retention, enable business expansion, and increase business attraction opportunities, which will help advance economic resiliency throughout the region.

Title of Project: Workforce Development Center Expansion Project

Project Location: Quincy/Adams County

EDA Investment: \$3,033,418

Local Match and Other Funding Sources: \$3,033,418

Brief Project Summary: This EDA investment supports the John Wood Community College with constructing a Workforce Development Center on its campus in Quincy. Brief Project Summary: This EDA investment supports the purchase of equipment for Uintah Basic Technical College automotive technician training and Commercial Driver's License programs. The project will support the response, recovery, and future resiliency of communities throughout rural Utah and the Uintah Basin in response to the coronavirus pandemic. The project will help increase the number of truck drivers, diesel technicians, and automotive technicians trained and hired in the area, which will create many additional opportunities for high wage, high-skill positions in response to a regional industry need for more professionals in these areas. The project is expected to create 733 jobs.

Title of Project: Medical Research Center Project

Project Location: Charlotte Amalie/Saint Thomas

EDA Investment: \$4,174,359

Local Match and Other Funding Sources: \$825,641

Brief Project Summary: This EDA investment amendment further supports the construction of a Medical Research and Training Center at the University of the Virgin Islands Medical School. Originally funded by EDA during FY 2019, the facility will focus on advanced innovations in medical research, education, and practice, and serve as a training ground for the use of new medical devices. The Center will be the United States Virgin Island's (USVI) first major step in developing medical tourism. The overall project is expected to leverage \$2 million in private investment, and have an estimated \$25 million annual economic impact on the USVI.

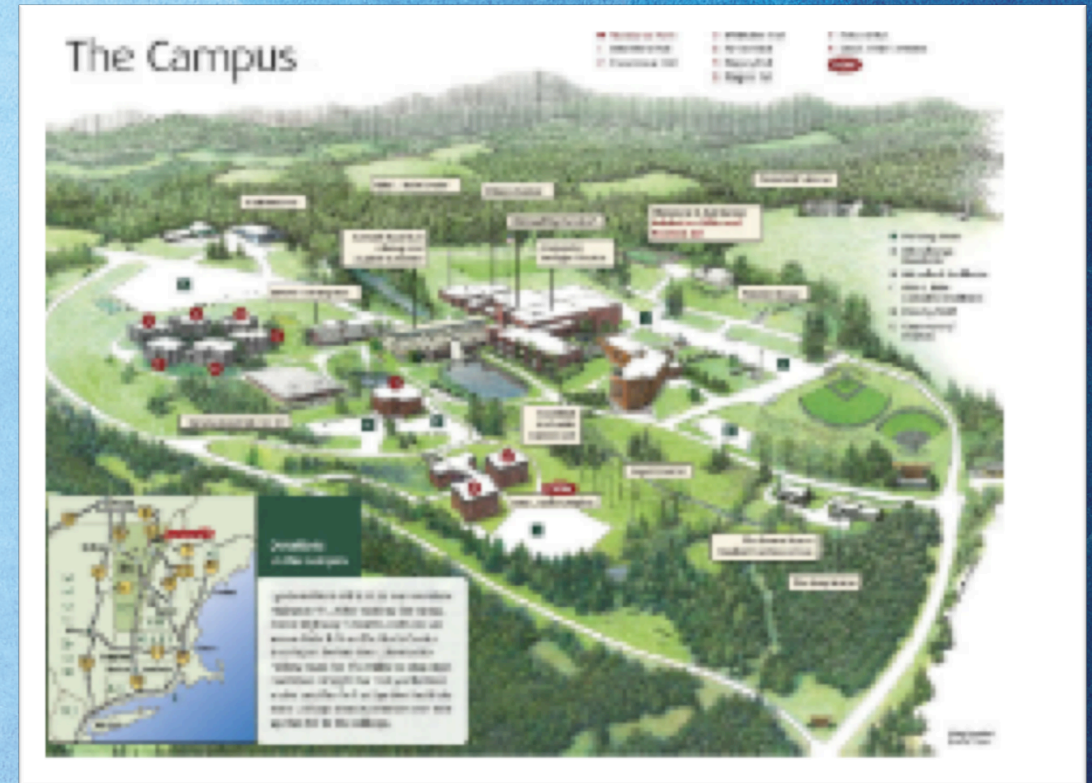

Local Match and Other Funding Sources: \$60,488

Brief Project Summary: This EDA investment funds the renovation and re-purposing of several different spaces including office, storage, and a computer lab area at Vermont State College's Lyndonville campus to establish an interactive teaching facility for a collaborative Health Sciences program. The new Clinical Nursing educational facility will provide a hands-on learning experience through the creation of a Skills Lab, Simulation Lab, a Control Room, and supplies area. The project is expected to create 10 jobs and save 35 jobs, which will assist the region with recovery efforts from the COVID-19 pandemic, support the health care industry, and advance economic resiliency throughout the region.



VIRGINIA

Recipient: Institute for Advanced Learning and Research

Title of Project: Training and Lab Equipment Project

Project Location: Danville/Danville County

EDA Investment: \$2,546,760

Local Match and Other Funding Sources: \$2,553,493

Brief Project Summary: This EDA investment supports the purchase of capital equipment to be used for the Industry 4.0 Integration and Training Initiative and Innovation Lab, housed at the new Center for Manufacturing Advancement located on the Institute for Advanced Learning and Research's (IALR) campus in Danville. The project will help build a work-ready pipeline of highly skilled workers who will be able to retool and integrate Industry 4.0 strategies into factories to automate systems and operations to include remotely monitored and controlled digital factories. The project is expected to create 403 jobs, save 800 jobs, and leverage \$83.5 million in private investment, which will ensure a more resilient manufacturing base, attract new industries, increase global competitiveness, and promote economic resiliency throughout the region.

Title of Project: Wood Innovation Center Project

EDA Investment: \$6,000,000

Local Match and Other Funding Sources: \$1,708,000

Brief Project Summary: This EDA investment supports the Town of Darrington with site work, infrastructure, utilities, and land purchase for development of the Darrington Wood Innovation Center. The Center will serve as a hub for the next generation of high-technology wood product companies, with the potential to revitalize the wood products after the industry suffered after the Oso mudslide in Darrington. The project is expected to create 156 jobs and leverage \$22 million in private investment, which will help advance economic resiliency throughout the region.



WEST VIRGINIA

Recipient: Marshall University Research Corporation

Title of Project: Aviation Maintenance Technology (AMT) Training Program Project

Project Location: Huntington/Cabell County

EDA Investment: \$975,000

Local Match and Other Funding Sources: \$1,759,813

Brief Project Summary: This EDA investment supports the Marshall University Research Corporation with launching a new AMT Training Program at the Robert. C. Byrd Institute on the campus of Marshall University to assist with supplying needed jobs to the aerospace industry in Cabell County. This region, comprising Ohio, Kentucky, and West Virginia, has a documented, severe shortage of certified mechanics. This project will be the first program in the region to offer joint degrees and the first school in the United States to use a virtual reality system to meet FAA training requirements for aviation paint and coating labs. The project is expected to create 122 jobs, which will help attract private investment to an area that has been impacted by the decline in the coal industry.

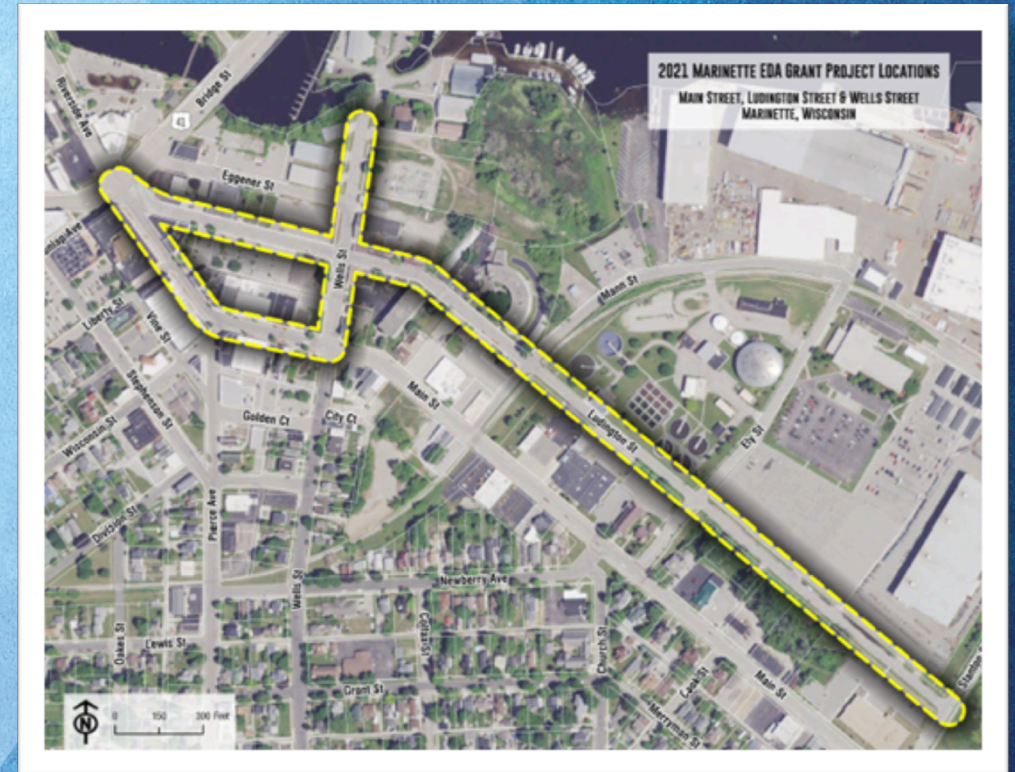
Title of Project: Downtown Roadway and Utility Improvements Project

Project Location: Marinette/Marinette County

EDA Investment: \$3,895,200

Local Match and Other Funding Sources: \$973,800

Brief Project Summary: This EDA investment supports the City of Marinette with reconstructing a central street system near the city's shipyard and developing additional nearby city-owned industrial property for new and expanding businesses in Marinette County. The project will establish a cutting-edge approach to meet the expected surge in the region's workforce and freight traffic by building a temporary infrastructure and testing support system to ensure smooth operations at the shipyard. The project is expected to create 420 jobs, save 1,760 jobs, and leverage \$24 million in private investment, which will assist the region with recovery efforts from the COVID-19 pandemic and advance economic resiliency throughout the region.



WYOMING

Recipient: University of Wyoming

Title of Project: IMPACT 307 Project

Project Location: Laramie/Albany County

EDA Investment: \$2,400,000

Local Match and Other Funding Sources: \$600,000

Brief Project Summary: This EDA investment supports the University of Wyoming with establishing IMPACT 307, an incubator program to serve the entire state of Wyoming through a hybrid virtual/personal startup launch and entrepreneurial support structure. The project will expand business incubation and launch support services by providing them in digital as well as physical environments, which will help diversify the base of employers within the state and help respond to the negative economic impacts of the COVID-19 pandemic. The project is expected to create 368 jobs and leverage \$1 million in private investment, which will help advance economic resiliency in an area that has been impacted by the decline in the coal industry.



EDA's FY 2021 Highlights

In Fiscal Year 2021, EDA invested approximately \$1.18 billion in 1007 locally-driven economic development projects nationwide.

These investments included approximately \$138.4 million in Public Works and Economic Adjustment Assistance (regular) construction projects that communities identified as critical infrastructure enhancements to ensure long-term competitiveness.

Recipients report that these investments are expected to create or retain 25,559 and generate \$5.04 billion in private investment. Additionally, these investments incentivized close to \$118.4 million in local matching investments.

EDA also supported economic development planning that will help communities make good decisions regarding long-term economic growth. In FY2021, EDA made 208 awards to regions and communities, providing them with approximately \$31.5 million to develop such plans.
