PUBLIC WORKS PROGRAM

The Public Works and Development Facilities Program, i.e., Public Works Program, empowers communities experiencing economic decline and distress to revitalize, expand, and upgrade their physical infrastructure to attract new industry, encourage business expansion, diversify local economies, and support the generation or retention of higher-skill, higher-wage jobs and investments.

The Public Works Program supports locally initiated and developed projects that encourage long-term economic self-sufficiency and global competitiveness. Examples of infrastructure and development facility investments supported by this program include water and sewer system improvements, skill-training facilities, industrial and business parks, industrial access roads, port and harbor improvements, business incubator facilities, multi-tenant manufacturing facilities, and tourism facilities.

Public Works investments are awarded to states, cities, or other political subdivisions, special purpose units of government, Indian tribes, and public or private non-profit organizations working in cooperation with a local political subdivision. The investments leveraged by Public Works grants support a variety of specific economic development strategies, including technology-led, entrepreneurial, cluster-based, aquaculture development; diversification of natural resource dependant economies; distance learning facilities; export development programs; commercialization and deployment of innovative technologies; and the redevelopment of brownfield sites.

Public Works investments may also be used to upgrade or expand an area's economic infrastructure to support the next generation of industry or commerce, such as telecommunications infrastructure and other sustainable development activities including eco-industrial parks. Whenever possible, the program seeks to redevelop existing facilities and rehabilitate older industrial and commercial sites rather than developing greenfield sites, because such investments promote sustainable economic development by taking advantage of readily available infrastructure, labor force, and markets.

Investment Eligibility for Public Works Assistance

To be eligible for consideration an investment must be located in an economically distressed area or, in the case of an investment located in a non-distressed area, it must provide substantial direct benefits to an economically disadvantaged area. In accordance with EDA's mission and authorizing legislation, distress is established by demonstrating one of the following criteria: high unemployment (at least 1 percent above the national average over a two-year period); low per capita income (that is, 80 percent or less of the national average per capita income); or other economic indicators defined as "special need" (e.g., substantial out-migration, underemployment, natural or other major disasters, extraordinary depletion of natural resources, or destructive impacts of foreign trade).

To be eligible for Public Works assistance, an area must demonstrate economic distress such as high unemployment, low per capita income, or other special need.

Additionally, an investment must also satisfy all of the following: 1) be consistent with a locally developed Comprehensive Economic Development Strategy (CEDS) that has been prepared for the area in which it will be located and which has broad community support; 2) improve opportunities for the successful establishment or expansion of industrial or commercial facilities in the area where it will be located; 3) fulfill a pressing need of the area and be started and completed in a timely manner; 4) not result in an increase of goods or services that exist in the market area; 5) have the required local matching share committed and available at the time of approval; and, 6) benefit the long-term unemployed and members of low-income families who are residents of the area to be served by the investment.

Analysis of Public Works Investments

In Fiscal Year 2000, 226 Public Works investments were approved for a total amount of \$204,511,963. The investment amounts ranged from a low of \$70,000 to a high of \$3,000,000. The average investment was \$904,920 and the median was \$846,500. EDA estimated that private investments on these will amount to approximately \$2.04 billion and that over 56,500 permanent jobs will be created or retained in distressed areas as a result of the EDA investments. On average, this results in approximately \$9.026 million in private investment and 250 jobs created or saved per each Public Works investment.

The distribution of Fiscal Year 2000 Public Works funds by type of development assistance was as follows: industrial 72.5 percent; commercial 7.8 percent; community 9.9 percent; human resources 6.4 percent; tourism/recreation 2.3 percent; and, institutional capacity 1.1 percent.

The investments focused on 24 different initiatives, which included the following: entrepreneurial development, clean water, enterprise zones, export development, technological innovation, historical preservation, sustainable development, empowerment zones, brownfields redevelopment, diversity of natural resources, forest initiative, welfare-to-work, enterprise communities, aquaculture, eco-tourism, energy related, product recycling, Mississippi Delta, Hurricane Floyd, Southwest border, health-related development, and pre-disaster mitigation activities.

The distribution of Fiscal Year 2000 Public Works funds by the type of recipient was as follows: city government \$114,985,163; county government \$23,613,195; special purpose unit \$18,208,255; college or university \$16,169,400; Indian group \$10,060,956; public non-profit organization \$7,616,000; private non-profit \$11,041,000; local development corporation \$3,267,000; county organizations \$1,650,000; and numerous other entities not otherwise classified above with individual amounts between \$1,000,000 and \$2,462,000.

Brownfields Redevelopment

EDA supports the revitalization and reuse of idle and abandoned industrial land and facilities, known as brownfields, and has done so for the past 35 years as a core component of its mission to aid the Nation's most economically distressed communities.

Brownfields redevelopment refers to the reuse of abandoned, idled, or underused industrial and commercial sites where expansion or redevelopment is complicated by real or perceived environmental contamination. Although brownfields may, at times, be more expensive to develop than greenfields (i.e., previously underdeveloped land), because of the need to assess the conditions of the site and sometimes reclaim the land, they have less of an impact on the environment.

Benefits of Brownfields Redevelopment

Brownfields are attractive to private companies due to their proximity to transportation systems such as highways, rail lines, and rivers; markets including both suppliers and customers; and readily available labor pools. Other brownfields redevelopment benefits include access to land with existing capital assets (e.g., buildings, power and telecommunications infrastructure, water, sewer, etc.), the availability of economic incentives, and unique redevelopment opportunities such as historic sites. Public-sector benefits include job creation, increased tax revenues, reduced urban sprawl, mitigation of health hazards, community and environmental stewardship, crime reduction, and prevention and elimination of neighborhood blight.

EDA's Public Works program investments help to revitalize, upgrade, and expand the physical infrastructure that is commonly needed for brownfields redevelopment. Such investments include the rehabilitation and reuse of older publicly owned buildings, as well as the construction of new facilities on reclaimed sites.

Analysis of Brownfields Redevelopment Investments

Fifty-eight brownfields investments totaling \$51,873,347 were approved by EDA in Fiscal Year 2000 and 19 of these, totaling \$18,696,100, were Public Works investments.

Native American and Alaska Native Economic Development

EDA has a long history of support for the economic development of Native American communities and Alaska Native villages. EDA has provided over three-quarters of a billion dollars in assistance to native communities to promote and support their economic development from 1965 through 2000.

In 1997, one-third of the Nation's indigenous households had incomes that placed them below the poverty line.

Analysis of EDA Investments to Native Communities

In Fiscal Year 2000, ten Public Works investments amounting to \$10,060,950 were made to Native American and Alaska Native tribal governments and included funding for the following: construction of buildings to house tribally owned manufacturing companies and commercial businesses; construction of workforce skill-training facilities; construction and equipping of distance learning facilities on reservations and tribally owned lands; aquaculture-related investments; and such facilities as cargo docks and cold storage facilities needed to enable Native American tribes and Alaskan Native villages to capitalize on the local availability of renewable natural resources. Including all EDA programs, 94 investments amounting to \$16,867,000 were awarded to Native American and Alaska Native tribal governments.

Frequently, the most successful Native American and Alaska Native investments approved by EDA are those that empower native communities to develop their cultural and natural resources and thereby promote their local economies.

Assessment of Infrastructure Needs in Native Communities

While the country continued to experience one of its longest and strongest economic expansions in its history, one segment of the Nation's population - Native Americans and Alaska Natives - for the most part, has been left behind the current economic boom and all those that came before. Among the highest distressed areas in the country, native communities continue to suffer from long-term economic deterioration and substantial poverty.

An EDA funded study, *Assessment of Technology Infrastructure in Native Communities*, published in June of 1999, revealed that the most pressing economic development needs are physical infrastructure, planning assistance, and workforce development. The study concluded that technology infrastructure alone cannot improve the economic conditions in native communities. For technology-led development to proceed, the study determined that native communities must first invest in basic infrastructure and worker training and then identify the resources required to finance technology-led investments.

Indian tribes and Native villages continue to suffer the highest poverty rate, an unemployment rate two-and-a-half times higher than the national average, a median family income that is less than two-thirds of the national average, and less than half of Indian homes have telephones.

ECONOMIC ADJUSTMENT ASSISTANCE PROGRAM

The Economic Adjustment Assistance Program responds to economic changes that occur suddenly or over time. These changes often result from industrial and corporate restructuring, natural disaster, reduction in defense expenditures, depletion of natural resources, or new federal laws or requirements. The Economic Adjustment Assistance Program assists state and local interests in the design and implementation of strategies to help correct a declining economy. The program focuses on areas that have experienced or are under threat of serious structural damage to the underlying economic base.

Economic Adjustment Assistance Program Investments

Economic Adjustment Program investments predominately support the three following types of investment activities:

- Strategy, or capacity-building investments that help communities organize and carry out a planning process resulting in a Comprehensive Economic Development Strategy (CEDS);
- Implementation, or construction investments that support one or more activities identified in an EDA-approved CEDS; and
- Revolving Loan Fund (RLF) investments that capitalize an intermediary to make loans to local businesses that otherwise could not access commercial credit.

A current EDA-approved CEDS is a prerequisite for an economic adjustment implementation or revolving loan fund investment.

Eligibility Criteria for Economic Adjustment Assistance Program Investments

EDA economic adjustment assistance may be awarded if an area meets any one of the following criteria demonstrating economic distress: high unemployment; low per capita income; disaster declaration; plant closures and layoffs; outmigration, underemployment, military base closure or defense contracting cuts; extraordinary depletion of natural resources; negative impacts of foreign trade; or other special need.

Area eligibility requirements for the Economic Adjustment Assistance Program, and the Public Works program are identical.

Analysis of Economic Adjustment Assistance Program Investments

The Economic Adjustment Assistance Program received an appropriation of \$34,629,000 in Fiscal Year 2000. Strategy or capacity-building investments accounted for 29.77 percent of the Economic Adjustment Assistance Program budget with 126 investments awarded. Implementation, or construction, investments accounted for 59.93 percent of the program budget with awards to 33 investments. Revolving Loan Funds received 10.3 percent of the program allocation with three investments awarded to RLFs.

Post Disaster Economic Recovery

Specialized Assistance

For the seventh consecutive year, EDA assisted states affected by declines in Appalachian coal and Southeastern timber, and supported the Pacific Northwest Timber Initiative.

Under the Economic Adjustment Assistance Program, EDA continued to support the Pacific Northwest Timber Initiative with investments totaling \$2 million in Fiscal Year 2000. The EDA role in this multi-agency initiative filled a critical gap by funding local capacity - building activities, such as economic adjustment strategies and technical assistance investments.

Additionally, EDA awarded investments totaling \$2 million for the Alaskan Timber Initiative. Also, \$8 million was made available for investments to assist areas affected by declines in Appalachian coal and Southeast timber.

Disaster Emergency Supplemental Appropriation for Alaskan Fisheries

On September 10, 1998, the Secretary of Commerce issued a Disaster Declaration under the Magnuson-Stevens Fishery Conservation and Management Act in response to the commercial failure of the Alaskan salmon fisheries in Bristol Bay and the Yukon and Kuskokwim River tributaries.

Under the Omnibus Appropriations Act of 1998, passed in September 1998, \$20 million in emergency supplemental disaster funding (no-year funds) was appropriated to respond to the fisheries disaster. Of this amount, \$14.1 million was designated to be used for investment activities under EDA's Economic Adjustment Program and \$5.0 million under EDA's Trade Adjustment Assistance Program.

Accordingly, by the end of Fiscal Year 2000, EDA had awarded \$11.538 million for 9 strategy and 11 implementation investments. Some examples of the type of investments are the following:

- **Alaska Seafood Marketing Institute (ASMI) in Juneau, Alaska**, received an EDA investment of \$4,800,000 to implement technical assistance tasks identified by ASMI in its strategic marketing plan prepared in Fiscal Year 1999. This investment will increase the sales of Alaskan salmon, benefitting Alaskans across the state.
- **Bristol Bay Housing Authority in Dillingham, Alaska**, received an EDA investment of \$1,200,000 to establish a vocational education center in the city of King Salmon on the site of a then-existing U.S. Air Force dormitory and office facility.
- **Bristol Bay Economic Development Corporation in Dillingham, Alaska**, received an EDA investment of \$600,000 to purchase and install eight portable ice-producing plants in selected communities, thus allowing fishermen to sell high-quality fish at higher prices.

Disaster Resistant Jobs

Disaster mitigation and EDA's Disaster Resistant Jobs initiative fall within the Economic Adjustment Program. Disaster mitigation provides pre-disaster planning and technical assistance for disaster-prone communities to take actions to mitigate against the adverse impacts of future disasters on the local economy. The result is a local economy that can better withstand the effects of natural disasters and insure the continuity of businesses and jobs. In Fiscal Year 2000, EDA awarded \$3,054,000 in disaster mitigation investments, which leveraged an additional \$2,928,000 in matching funds for 39 investments totaling approximately \$5,982,000 in 22 states.

EDA-funded disaster mitigation investments are locally directed community activities that contribute to permanent solutions in loss reduction and reduced risk to jobs and protection to the economic vitality of hazard-prone communities.

EDA continues to work closely with the Federal Emergency Management Agency to address critical business and economic aspects of pre-disaster economic preparedness, through the Disaster Resistant Jobs initiative.

Strategic economic recovery planning and/or technical assistance investments focusing on disaster mitigation help communities protect jobs and reduce economic consequences of future natural disasters.

New Tools Support Investment

\$10.3 Million in New Capital for Revolving Loan Funds

During Fiscal Year 2000, EDA funded multiple Securitization Demonstration Investments. Together, these investments illustrate different ways in which a RLF can raise new private lending capital by leveraging their existing loan portfolios asset value. These investments are outlined, briefly, in the following examples:

- **Racine County Economic Development Corporation, Racine, Wisconsin**, received a \$30,000 EDA investment to establish a \$1 million line-of-credit from a consortium of local banks that were secured, in part, by the RLF's existing portfolio.
- **South Dakota Rural Development Enterprise, Inc. (SDRDEI), Sioux Falls, South Dakota**, a non-profit Community Development Financial Institution, used its \$263,000 EDA investment to obtain up to \$5 million in unsecured borrowing from banks and other institutions in the state. The banks received Community Reinvestment Act credit and Bank Enterprise Awards and SDRDEI, in turn, lends the funds to RLFs throughout the state.
- **Community Reinvestment Fund (CRF), Minneapolis, Minnesota**, received a \$300,000 EDA investment, and using additional funds, purchased over 90 EDA RLF loans, generating over \$4.3 million of new non-government funds for the RLFs. CRF then packaged the loans with others and sold the securities to private investors.

EDA is the acknowledged leader among federal agencies and within the broader economic development community in its pursuit of a viable secondary market for economic development loans, particularly RLF loans.

**INVESTMENT PROGRAMS
OF THE
ECONOMIC DEVELOPMENT ADMINISTRATION**

Defense Economic Adjustment Assistance Program

With the end of the Cold War and the reduction of the military force structure, Congress approved four Base Realignment and Closure (BRAC) rounds to close military bases throughout the United States. EDA has been involved in the BRAC rounds of 1988, 1991, 1993, and 1995. Since 1992, EDA has awarded \$615 million in defense adjustment assistance investments to approximately 113 counties in 38 states affected by base closures. Additionally, EDA received approximately \$252 million from the Department of Defense and \$8 million from the Department of Energy appropriations for specially targeted defense adjustment investments.

Analysis of Defense Economic Adjustment Assistance Program Investments

In Fiscal Year 2000, the Defense Adjustment Assistance Program received an appropriation of \$77,300,000 plus an additional \$17,597,834 in defense adjustment funds transferred from other agencies. Over 81 percent of this amount funded 50 investments for the purpose of constructing new or replacement infrastructure on closing military installations and Department of Energy sites. Six percent of the Program funds were awarded to 15 investments to provide technical assistance. Twelve percent of the Program funds were awarded to 11 investments to provide strategy and planning investments. Less than 1 percent of the Program allocation was awarded to fund one RLF investment.

Defense Adjustment Assistance investments fill a critical role in initiating economic development for communities implementing base reuse plans.

Finalizing Base Realignment and Closure (BRAC) 1995

With the last BRAC occurring in 1995, most installations have already closed or will be closing by 2001. After such time, communities may continue to qualify for Defense Adjustment Assistance investments based on economic distress levels or other eligibility criteria. Final transfer of property is generally dependent on environmental cleanup, which remains a Department of Defense responsibility.

ECONOMIC DEVELOPMENT PLANNING PROGRAMS

The Economic Development Planning Program provides essential financial investment support to Economic Development Districts (EDDs), Native American organizations, states, sub-state planning regions, urban counties, cities, and other eligible applicants to assist in planning. The two categories of the Planning Programs are: Partnership Planning investments for Economic Development Districts, Indian Tribes, and other eligible areas; and, Short Term Planning investments to states, sub-state planning regions, and urban areas.

EDA considers planning the underpinning of all other EDA investments.

Analysis of Economic Development Planning Investments

In Fiscal Year 2000, 317 EDA investments under the District Partnership Planning Program totaled \$17,845,000 in support of 326 districts and four eligible areas. One of the investments supports 14 districts in Kentucky. An additional 61 investments totaling \$2,711,392 were made under the Indian Tribe Partnership Planning Program. Under the Short Term Planning Program, EDA provided an additional 2 awards for \$180,000 to Indian Tribes as well as 20 other awards to rural entities for \$966,618, 12 awards to states for \$1,028,490, and 14 awards to urban entities for \$1,167,500.

Partnership Planning Investments for Economic Development Districts, Indian Tribes, and Other Eligible Areas

Partnership planning investments provide support for the formulation and implementation of local economic development programs and strategies designed to create and retain permanent jobs and to increase income for the unemployed and underemployed in areas of economic distress. EDA investments enhance economic development planning capability, support the formulation of development policies, and assist in building local institutional capacity.

Eligible activities under this program include preparing and maintaining a Comprehensive Economic Development Strategy and process; implementing the elements of the strategy; and, providing planning and technical assistance services to communities and local governments within the organization's jurisdiction. EDA investments are normally awarded on an annual basis and priority consideration is given to currently funded entities with satisfactory performance.

In Fiscal Year 2000, examples of EDA Partnership Planning investments include the following:

Planning and Development District III (PADD III) in South Dakota, which was designated as an economic development district in 1976, received a \$53,000 District Planning Partnership Investment. PADD III, a leader in South Dakota Geographic

Information System (GIS) technology, is helping its member counties and communities to use this technology in their community and economic development efforts. PADD III is also assisting in the rejuvenation of another EDD in South Dakota by helping to reestablish a Comprehensive Economic Development Strategy committee in the area and to prepare an updated CEDS. PADD III is undertaking other activities which include the following:

- Preparation of six community or industrial access applications; over 45 applications for infrastructure development; and 21 state water plan applications or amendments;
- Compilation of a regional labor survey for the South Dakota Department of Labor;
- Assistance to five communities and two counties for a variety of activities, including promotional and marketing activities, development of a community website, and Main Street redevelopment; and,
- Assistance to ten counties, six communities, and one tribal government for the preparation of comprehensive plans.

Affiliated Tribes of Northwest Indians (ATNI) is a consortium of 50 tribes from Alaska, Washington, Oregon, Idaho, California, and Montana. EDA awards partnership planning investment assistance to ATNI on an annual basis to provide economic development planning and implementation expertise to member Tribes in this six-state area. With the Fiscal Year 2000 funds, ATNI is updating the regional tribal development strategy, organizing a Revolving Loan Fund to develop businesses on the reservations, preparing a tribal energy development program, identifying successful tribal economic development activities for replication by other tribes, and training tribal leaders and planners in sophisticated economic development techniques.

Short Term Planning Investments to States, Sub-State Planning Regions, and Urban Areas

Short Term Planning investments support significant new economic development planning, policymaking, and implementation efforts and establish comprehensive economic development planning processes cooperatively with the state, state political subdivisions of the state, and economic development districts. Investments under this program are generally for a 12-month period and assistance may be renewed for two additional years.

Economic development planning and implementation activities such as economic analysis, defining economic development goals, identifying project opportunities, and formulating and implementing development programs may be funded under this program. Other eligible activities include preparing and maintaining a comprehensive economic development planning process, coordinating

multi-jurisdictional planning efforts, developing institutional planning capacity, and identifying approaches for diversifying the local economy. Any state receiving assistance under the program is required to maintain a Comprehensive Economic Development Strategy developed in cooperation with its political subdivisions and economic development districts.

Examples of Fiscal Year 2000 EDA Short Term Planning investments include the following:

Kentucky Department of Local Government was awarded \$120,000 to establish an economic GIS for the central and western portions of the state. This investment complements a similar GIS activity for eastern Kentucky that was funded by the Appalachian Regional Commission and the state.

This Short Term Planning investment permits users to identify development sites in the area that meet specified parameters, estimate delivery times for product delivery from the site, estimate the availability of workers, and prepare high-quality maps. It also permits sophisticated comparison of this data for different sites in the region. The base maps and data base are helping Kentucky communities to identify and overcome barriers that inhibit local economic growth and their ability to compete in regional, national, and global markets.

Warren Conner Development Coalition, Detroit, Michigan, was awarded \$73,000 to support a land assembly initiative in eastern Detroit. Coalition officials are using these investment funds to identify land parcels that can be acquired for development, determine if any critical issues or complications are associated with those parcels, support coalition staff development and team building, conduct property and title research on promising parcels, prepare mapping presentations of those parcels, improve its capacity for undertaking strategic planning, and strengthen its ability to create partnerships with the Detroit city government to improve the economic base of the neighborhood.

TECHNICAL ASSISTANCE PROGRAMS

Local Technical Assistance Program

The Local Technical Assistance Program helps leaders in the public and non-profit sectors, especially those in distressed communities, to gain essential information for making optimal decisions on local economic development issues. Investments funded under this program most commonly assist communities in analyzing the feasibility of an economic development investment, such as a business incubator or industrial park, or creating new or retaining existing jobs in the local economy. However, the strength of the Local Technical Assistance Program lies in its flexibility to address a broad range of local economic development needs and opportunities. EDA investments under this program may also assist communities in preparing downtown revitalization strategies, tourism marketing plans, and export marketing programs for locally produced goods and services, and conducting targeted economic development studies, such as an analysis of local labor skills and needs.

Analysis of Local Technical Assistance Investments

EDA awarded 62 Local Technical Assistance investments, totaling \$1,711,706 in Fiscal Year 2000. The distribution of Fiscal Year 2000 Local Technical Assistance investments by type of development assistance is as follows: 13 investments funded feasibility studies of potential economic development investments; ten investments supported the preparation of development plans for specific investments or geographic areas; and, six investments supported economic development conferences or summits. Ten of the Fiscal Year 2000 investments, totaling \$187,577, were awarded with funds reimbursed by the Federal Emergency Management Agency to assess the local economic impact of natural disasters, including Hurricane Floyd.

Examples of Fiscal Year 2000 EDA Local Technical Assistance investments include the following:

Central New York Regional Planning and Development Board was awarded \$36,000 to establish a comprehensive regional telecommunications data base. This investment is assisting local officials to gain a better understanding of the telecommunications industry and how the Central New York region compares in that industry with other parts of the U.S. The investment is supporting the creation of a comprehensive inventory of the telecommunication resources in central New York, including the identification of major companies and the location of major transmission lines, fiber-optic service, access points, cell towers, and system capacities.

Shoshone Business Council in Wyoming received a \$15,000 Local Technical Assistance investment to prepare a facility plan for a multi-purpose center. This investment is helping the Council to assess several proposed uses for the building, including an historic and cultural heritage center, a business incubator, and a tourism

center; to determine the size, design, location, and construction cost of the building; and, to prepare a financial plan for constructing the facility. The facility also complements an overall tourism promotion plan which has been supported by Fremont County and the State of Wyoming.

Governors State University in Illinois received a \$75,000 investment to develop regional initiatives for expanding employment in high technology in the suburbs of south Chicago. With these investment funds, Governors State University is identifying and evaluating the current levels of job skills, needs, and opportunities in the metal fabricating industry. It is also working with a major automotive manufacturer, a major labor union, the local community college, and other interested parties to identify and coordinate the best uses of a new public or private high technology and robotics training center for job expansion and retraining. Finally, the University is developing a detailed regional economic profile to support further job development initiatives in metal fabricating and other industries in the region. This investment complements the \$10 to \$12 million commitment over the next five years by the automotive manufacturer and a \$6 million commitment by the State of Illinois to build this high technology and robotics center.

EDA considers the 69 University Centers as long-term partners in economic development.

Central Puget Sound Economic Development District in Washington was awarded a \$53,226 Local Technical Assistance investment to help small cities and towns in a four-county area to prepare strategies to guide local development investments, land-use decisions, and marketing activities. This investment helps community officials recognize local competitive advantages, define appropriate decision mechanisms for determining efficient and effective development practices, identify sources of financial and programmatic implementation assistance, evaluate the benefits and costs of proposed activities, identify short and long-term actions necessary to implement the strategies, and prepare preliminary environmental reviews of proposed activities.

University Center Technical Assistance Program

Institutions of higher education house a wealth of resources, including faculty, staff, computer facilities, laboratories, and libraries. The University Center Technical Assistance Program helps institutions of higher education establish and maintain outreach programs, which use their own and other resources to provide technical assistance that addresses economic development needs and opportunities in their service areas, especially in distressed communities.

EDA considers the 69 University Centers as long-term partners in economic development. The majority of the University Centers assist non-profit organizations and units of local government in analyzing and implementing economic development projects and programs. Most other University Centers focus their programs on providing private sector firms with technology transfer assistance to help create or stabilize job opportunities. Five of the University Centers are sponsored by Hispanic serving institutions and eight are sponsored by historically Black colleges and universities.

Analysis of University Center Technical Assistance Investments

EDA renewed its financial assistance to the 69 University Centers in Fiscal Year 2000 and awarded \$6,531,067 in Technical Assistance funding and \$549,000 in other funding, for a total of \$7,080,067. The following are representative investments made under the University Center Technical Assistance Program in Fiscal Year 2000.

St. Cloud State University in Minnesota received \$100,000 to provide technical assistance and training for economic development groups and local governments in Minnesota. The University Center targets its efforts to organizations in the non-metropolitan areas of Minnesota. Much of this University Center's work focuses on assisting local officials with economic data and analysis for use in regional planning or in assessing potential economic development activities.

Weber State University in Utah received \$90,000. This University Center focuses its efforts on assisting Utah's manufacturing firms with technology transfer to solve technical or engineering problems. While this University Center has a statewide service area, firms in distressed areas of the state receive particular attention.

University of Maryland Eastern Shore, one of the Nation's historically Black colleges and universities, received a \$108,000 investment for the operation of its University Center. The service area of the University Center consists of several rural Maryland counties located between the Chesapeake Bay and the Atlantic Ocean. These counties are still experiencing the effects from past plant closures and defense cutbacks. The University Center assists these counties and their communities in analyzing the feasibility of economic development proposals and their potential for success.

Research and National Technical Assistance Program

The Research and National Technical Assistance Program develops a comprehensive base of information about economic development issues; disseminates information to local, state, and national economic development practitioners; and evaluates the performance of economic development programs. Information dissemination investments make crucial information on economic development programs, projects, and emerging issues available to practitioners through targeted newsletters, Web sites, conferences, and other media. Research investments examine existing and emerging issues in economic development, and document the results for practitioners and policymakers. Evaluation investments assess the economic impact of funding under EDA's programs to measure each program's effectiveness and make recommendations for their improvement.

Fourteen Research investments totaling \$525,517 were awarded in Fiscal Year 2000. Examples of these research investments include the following:

Through the National Technical Assistance Program, EDA awards information dissemination, research, and evaluation investments.

- Wayne State University of Detroit, Michigan, was awarded \$204,000 to evaluate the impact of funding of Economic Development Districts under EDA's Planning Program.
- Case Western Reserve University of Cleveland, Ohio, was awarded \$29,500 to consider how older central counties should approach spatial planning in the New Economy.
- The National Center for Small Communities of Washington, D.C., was awarded \$84,631 to study best practices in technology-led economic development in distressed rural communities.

Fifteen National Technical Assistance investments totaling \$1,211,897 were awarded in Fiscal Year 2000. Examples of these projects include the following:

Through its Research and National Technical Assistance Program, EDA develops and disseminates information about economic development issues to practitioners, and measures the performance of economic development programs.

- The National Council for Urban Economic Development (now the International Economic Development Council) of Washington, D.C., was awarded \$150,000 to manage a national economic development forum in Washington, D.C.
- East Carolina University of Greenville, North Carolina, was awarded \$28,898 to assess the economic impact of a sustainable development partnership in coastal North Carolina.
- The Oklahoma Institute of Indian Heritage of Norman, Oklahoma, was awarded \$69,000 to develop and disseminate information on a best-practice tribal economy model.

TRADE ADJUSTMENT ASSISTANCE PROGRAM

Trade opening agreements, such as General Agreements on Tariffs and Trade and the World Trade Organization, benefit many U.S. firms by increasing their access to the international marketplace. Other U.S. firms, however, find that these same agreements have eroded their domestic markets by making it easier for their customers to purchase imported goods.

EDA provides technical assistance through a national network of 12 Trade Adjustment Assistance Centers.

The Trade Act of 1974, as amended, authorizes EDA to provide technical assistance to firms and industries which have lost sales or production and employment to increased imports of similar or competitive goods. EDA uses a national network of 12 Trade Adjustment Assistance Centers (TAACs), authorized under Chapter 3, of Title II of the aforementioned Act, to assist these trade-injured firms.

Investment Eligibility Criteria for Trade Adjustment Assistance

Only trade-injured manufacturers and producers are eligible to receive assistance under the Trade Adjustment Assistance (TAA) program. The program cannot provide assistance to retail or service firms.

Investments to operate TAACs may be awarded to institutions of higher education, non-profit organizations, or other appropriate entities. In Fiscal Year 2000, seven TAACs were sponsored by institutions of higher education, three by single purpose non-profit organizations, one by an employers association, and one by a state agency.

Analysis of TAAC Program Activities

In Fiscal Year 2000, EDA awarded \$10,500,000 in TAA funding to the national TAAC network. An additional \$456,000 of defense adjustment funds were awarded to TAACs to assist trade-injured firms that were also experiencing defense downsizing or were located in areas experiencing defense downsizing. EDA certified 201 firms as eligible to apply for assistance under the Trade Adjustment Assistance Program and approved adjustment proposals from 139 firms during Fiscal Year 2000. These 139 firms had an average of 126 employees and \$10,800,000 in sales. Under the program, the firm must share in paying the costs of consultants fees for implementing the technical assistance tasks outlined in the firm's adjustment proposal. EDA and the firm's combined shares of the technical assistance implementation outlined in the adjustment proposal averaged \$100,000.

Examples of technical assistance tasks contained in adjustment proposals prepared under Fiscal Year 2000 EDA Trade Adjustment Assistance investments include the following:

- \$150,000 for a precious metal jewelry manufacturer to design, develop, install, debug, and train employees on a new management information system to aid production efficiencies;
- \$70,000 for a large machine shop manufacturer that produces close-tolerance jet engine components to develop an in-house, customized apprentice program to provide needed skills to potential future employees, enabling the company to grow its work force;
- \$75,000 for a manufacturer of grey and ductile iron and aluminum castings for a densification process designed to enable the company to cast higher quality and higher strength aluminum castings for safety related automobile parts;
- \$170,000 for a plastic injection molded container manufacturer to develop a plant workflow and productivity improvement program to increase production efficiencies and reduce the company's manufacturing costs;
- \$90,000 for a processor of salmon, halibut, and other fish and seafood products to develop a corporate identity program, including a company logo; an updated company brochure; and development of a new Web site to advertise the company's products; and,
- \$12,500 for a printing press and parts manufacturer to improve its computer-aided design and computer-aided manufacturing systems and provide the requisite training for machine operators to provide for a more efficient manufacturing operation.
