Statement from the Deputy Assistant Secretary of Commerce for Economic Development

I am pleased to report to Congress the accomplishments of the U.S. Department of Commerce Economic Development Administration (EDA) for fiscal year 2012. During the year, EDA continued to work collaboratively with public- and private-sector partners to break down bureaucratic silos and maximize the effectiveness of its programs in supporting economic growth and job creation in regions throughout the United States.

Two initiatives that EDA led in FY 2012— the Rural Jobs and Innovation Accelerator Challenge and the Advanced Manufacturing Jobs and Innovation Accelerator Challenge—exemplify these efforts.

The Rural Jobs and Innovation Accelerator Challenge marshaled the resources of EDA and 12 other federal agencies to make \$9 million worth of investments in 13 organizations across the country that today are leveraging their local assets to support industry clusters and partnerships. Their programs will have a catalytic effect, helping entrepreneurs and small businesses foster innovation, increase regional competitiveness, and employ highly skilled workers in rural regions throughout the country.

The Advanced Manufacturing Jobs and Innovation Accelerator Challenge was an initiative that brought together EDA and five other federal agencies to award \$20 million to 10 public-private partnerships. These partnerships are supporting local efforts to spur job creation through a variety of projects, including initiatives that connect innovative small suppliers with large companies, link research with the start-ups that can commercialize new ideas, and train workers with skills that firms need to capitalize on business opportunities.

This initiative is a testament to the Obama Administration's commitment to protecting and growing America's manufacturing sector. Manufacturing has the highest multiplier effect of any industry. It is responsible for 70 percent of private-sector R&D, 90 percent of our patents, and 60 percent of our exports. Most important, it is a critical jobs generator for America's middle class, adding hundreds of thousands of jobs to the economy in recent years.

These two Challenges, along with EDA's regular programs and other targeted investments such as the successful third round of the i6 Challenge and the continued support of the Strong Cities Strong Communities Initiative—are making long-term investments to better equip America's regions to compete in both the domestic and global marketplaces. And they build on EDA's nearly 50 year history of supporting regionally-driven economic development strategies by focusing on creating opportunities that encourage regions to plan for their long-term stability, build on their unique assets, and create the conditions for the private sector to flourish and create jobs.

In FY 2012, EDA awarded approximately \$297 million to support 674 investments through its Economic Development Assistance Programs and disaster relief funding. These investments included construction projects that many communities determined would enhance their local economic development efforts. In FY 2012, EDA invested approximately \$194 million in such construction projects, which are expected to help create or retain approximately 40,000 jobs and generate nearly \$4.6 billion in private investment, according to grantee estimates.

EDA also worked with communities by funding regional planning strategies that help them make smart decisions regarding their long-term economic growth. In FY 2012, EDA made 327 awards to regions and communities, providing them with \$29 million to develop such plans.

As the only federal government agency with economic development as its sole mission, EDA is uniquely positioned to address needs that are not met by other public- and private-sector resources. And the success of its investments shows that when the right partners in regional economic ecosystems come together and increase their level of interaction, good things happen for job creation, investment, and improved prosperity. It is through such efforts that EDA is working to ensure that America is not just able to face the challenges of the 21st century economy, but to prosper and grow for years to come.

EDA Highlights for Fiscal Year 2012

Strengthening Economic Growth and Creating Jobs

As the United States continued to recover from the deepest economic downturn in recent history, EDA investments supported economic growth in distressed communities and promoted long-term strategies and projects that will provide the foundation for business growth and job creation for many years to come.

During 2012, EDA continued to help regions strategically build strong economic ecosystems that will support entrepreneurship and business growth, enhance and grow their existing economic assets and create well-paying jobs in growing sectors. By investing in bottom-up regional economic development EDA helped communities devise new, well-thought-out, sustainable strategies based on their unique assets.

Accelerating Job Creation and Regional Innovation

Across the country, rural and urban communities are looking for new ideas and new engines for job creation. In response to this need, EDA offered a series of competitive grants for regional initiatives. These grants brought together various regional players with strategic action plans forming new and innovative partnerships between business, higher education, and government.

Investing in Rural Communities

One of these competitions— the **Rural Jobs and Innovation Accelerator Challenge**—focused on strengthening rural communities. In line with other silo-busting efforts of the Obama Administration, EDA, along with 12 federal partner agencies, implemented the challenge which offered \$9 million to help fund efforts that accelerate economic and job growth across rural regions.

Joining EDA in funding this challenge were the U.S. Department of Agriculture, the Appalachian Regional Commission, and the Delta Regional Authority. It was supported by nine other federal agencies.

The competition funded 13 rural partnerships (see sidebar) focusing on a wide range of industrial sectors, including advanced manufacturing, agribusiness, energy and natural resources, technology, and tourism. By leveraging local assets, the selected industry clusters and partnerships will be able to do even more to help small enterprises foster innovation, increase competitiveness, and employ highly skilled workers.

Supporting the Growth of Advanced Manufacturing

In order to maintain its competitive edge in the global economy, the United States also needs to make more things that the rest of the world wants to buy. In FY 2012, EDA joined six other federal agencies in the **Advanced Manufacturing Jobs and Innovation Accelerator**Challenge, a competitive grant process designed to support initiatives that strengthen advanced manufacturing at the local level.

The 10 public-private partnerships funded by the challenge (see sidebar) consist of colleges, nonprofits, and other local stakeholders that in turn provide services to small and large businesses in a particular area. The \$20 million in total awards made available by this challenge are helping the winning clusters support local efforts to spur job creation through a variety of projects, including initiatives that connect innovative small suppliers with large companies, link research with the start-ups that can commercialize new ideas, and train workers with skills that firms need to capitalize on business opportunities.

The awards will help regional clusters grow by strengthening their connections to regional economic development opportunities and advanced manufacturing assets, helping develop a skilled and diverse advanced manufacturing workforce, increasing exports, encouraging the development of small businesses, and accelerating innovation in technology.

The winning initiatives are expected to train a total of 1,000 workers and help nearly 650 companies leverage their cluster's resources in their regions and create jobs across the country.

Driving Innovation into the Marketplace

In 2012, EDA participated in the third round of the **i6 Challenge** and made seven new awards. This national competition was first launched in 2010 to advance American innovation, foster entrepreneurship, increase the commercialization of research and ideas into viable companies, and create jobs. It seeks to accelerate innovative product development, spur the formation of start-ups, and create small businesses by supporting Proof of Concept Centers at universities and research consortiums across the country.

The 19 winners from all three rounds of the competition are helping to jumpstart the production of emerging technologies and revolutionize manufacturing processes. The Proof of Concept Centers that have been funded incorporate a range of services, such as technology and market evaluation and business planning, that are critical to regional economic growth and job creation.

The i6 Challenge is led by the U.S. Department of Commerce's Economic Development Administration's Office of Innovation and Entrepreneurship. The office leads efforts to promote innovation-based, high-growth entrepreneurship, develops policy recommendations, and implements initiatives to commercialize technology developed through university and federally-funded research.

Economic Development Administration Overview

Established under the Public Works and Economic Development Act (PWEDA) of 1965, as amended (42 U.S.C. § 3121 et seq.), the Economic Development Administration has helped communities generate jobs, retain existing jobs, and stimulate industrial and commercial growth for more than 45 years.

As the only federal government agency focused exclusively on economic development, the U.S. Department of Commerce's Economic Development Administration (EDA) plays a critical role in fostering regional economic development efforts in communities across the nation.

EDA's investments establish a foundation for sustainable job growth and the building of durable regional economies throughout the United States. This foundation builds upon two key economic drivers: innovation and regional collaboration. Innovation is the key to global competitiveness, new and better jobs, a resilient economy, and the attainment of national economic goals. The new global economy is built on centers of competition, and those regions that work together to leverage resources and use strengths to overcome weaknesses will fare better than those that do not.

Guided by the basic principle that communities must be empowered to develop and implement their own economic development and revitalization strategies, EDA works directly with local economic development officials through a bottom-up approach. This collaboration results in grant investments that are well defined, timely, and linked to a long-term sustainable economic development strategy. Linking EDA's investments to a community's strategic economic development plan enables the Federal Government to better leverage public and private sector investments.

EDA's flexible programs and structure enable nimble operations and allow for innovation and responsiveness to changing economic needs and conditions faced by its local and state government partners. EDA's economic footprint is wide and its tool box is extensive—including technical assistance, post-disaster recovery assistance, trade adjustment support, strategic planning and research and evaluation capacity, thereby allowing the agency to offer the most effective investment to help communities succeed in the global economy.

EDA Programs

EDA's programs (see sidebar box) offer a complementary, balanced portfolio of tools that are designed to help rural and urban communities evolve through the economic development process to become robust regional engines for business creation and job growth.

EDA Programs

- **➤ Public Works and Economic Development:** Supports the construction, expansion, or upgrade of essential public infrastructure and facilities.
- ★ Economic Adjustment Assistance: Provides a wide range of technical, planning, and public works and infrastructure assistance in regions experiencing adverse economic changes that may occur suddenly or over time (for example, strategy development, infrastructure construction, and revolving loan fund capitalization).
- ★ Planning Assistance: Assists local and regional organizations (such as district organizations, Indian Tribes, and other eligible entities) with their short- and long-term planning efforts.
- ★ Technical Assistance: Provides focused assistance (such as project planning, economic impact analyses, and feasibility studies) to public and nonprofit leaders to help in economic development decision-making. Also includes the University Center Economic Development Program, which makes the resources of universities available to the economic development community.
- ★ Research and Evaluation: Supports research of cutting-edge economic development practices, as well as information dissemination efforts to national audiences.
- ★ Trade Adjustment Assistance for Firms: Supports a national network of 11 Trade Adjustment Assistance Centers that assist U.S. small and medium-sized businesses that have been impacted by

Public Works and Economic Development Assistance

EDA's Public Works and Economic Development investments help distressed communities revitalize, expand, and upgrade their physical infrastructure. This program enables communities to attract new industry; encourage business expansion; diversify local economies; and generate or retain long-term, private-sector jobs and investment through the acquisition or development of

land and infrastructure improvements needed for the successful establishment or expansion of industrial or commercial enterprises.

Public Works investments help facilitate the transition of communities from being distressed to becoming competitive in the worldwide economy by developing key public infrastructure, such as technology-based facilities that utilize distance learning networks, smart rooms, and smart buildings; multitenant manufacturing and other facilities; business and industrial parks with fiber optic cable; and telecommunications and development facilities. In addition to these, EDA continues to invest in its traditional Public Works projects, including water and sewer systems improvements, industrial parks, business incubator facilities, expansion of port and harbor facilities, skill-training facilities, and brownfields redevelopment.

Economic Adjustment Assistance

The Economic Adjustment Assistance (EAA) program uses a flexible set of tools to respond to the wide range of economic development challenges in communities and regions across the nation, including globalization, natural resource depletion, corporate restructuring, and natural disasters.

EAA is the most effective single program in EDA's arsenal to address areas impacted by globalization, especially manufacturing dependent communities that need to develop and implement regional strategies that will transform and diversify their economies and position them competitively in the global marketplace. EAA funds can be used to design the transition strategy, construct or upgrade public infrastructure, and capitalize locally or regionally administered Revolving Loan Funds that directly assist innovative entrepreneurs in growing 21st century businesses.

Additionally, the EAA program, with its forward-looking "imminent threat" authority, allows EDA to initiate interventions before a community's economy bottoms out, when economic trends may clearly indicate the need for intervention but the trailing economic eligibility indicators employed in other programs may not provide adequate access to other assistance.

Revolving Loan Fund Program

As part of the Economic Adjustment Assistance Program, EDA makes grant-based co-investments with units of state and local government and nonprofits to establish lending programs through its Revolving Loan Fund (RLF) Program. This expands capital access opportunities to small businesses in distressed regions at below-market rates or when funds are otherwise unavailable from private lenders. Grant recipients typically must contribute matching dollars to capitalize the fund. Revolving Loan Funds operate, in principle, by issuing new loans as old loans are repaid. Eligible uses for loans include real estate, equipment, fixed assets and working capital. As of April 2013, the RLF program encompassed 564 RLFs, with a combined capital base of \$848 million

Economic Development Planning Assistance

The Economic Development Planning Assistance program provides essential investment support to district organizations, Native American organizations, states, sub-state planning regions, urban counties, cities and other eligible recipient to assist in planning. The two categories of the Planning Assistance program are: (a) planning investments for District Organizations, Indian Tribes and other eligible entities; and (b) short-term planning investments to states, sub-state planning regions and urban areas. Eligible activities under this program include developing,

maintaining, and implementing a Comprehensive Economic Development Strategy (CEDS) and related short-term planning activities.

Technical Assistance

EDA administers the University Center Economic Development program, the Local Technical Assistance program, and National Technical Assistance program. These three programs help promote economic development and alleviate unemployment, underemployment, and outmigration in distressed regions.

Institutions of higher education have extensive resources, including specialized research, outreach and technology-transfer and commercialization capabilities, as well as recognized faculty expertise and sophisticated laboratories. The EDA-supported **University Center** (UC) program is specifically designed to marshal the resources located within colleges and universities to support regional economic development strategies in regions of chronic and acute economic distress. The UCs, which EDA considers long-term partners in economic development, are required to devote the majority of their funding to respond to technical assistance requests originating from organizations located in the economically distressed portions of their service regions.

The UCs have a long history of promoting and facilitating economic development in their service regions. They have often been among the first to recognize emerging technical assistance needs. As early as 1980, for example, EDA-funded UCs recognized and responded to the needs of small and medium-sized manufacturers and processors for technology transfer and commercialization assistance.

Most UCs focus their efforts on assisting units of local governments and nonprofit organizations in planning and implementing regional economic development strategies and projects. Typical activities provided by the UCs include targeted commercialization of research, workforce development, and business counseling services. Other UCs may focus their efforts on helping local organizations with conducting preliminary feasibility studies, analyzing data, and convening customized seminars and workshops on topics such as regional strategic planning and capital budgeting.

EDA began administering the University Center Economic Development Program on a competitive, multi-year basis in FY 2004, holding competitions each fiscal year in two of EDA's six regional offices. In FY 2012, EDA's regional offices in Seattle and Atlanta held their third round of competitions. During this year, EDA invested \$16.2 million in 58 UCs, including second- and third-year funding awarded to centers selected in prior years.

The **Local Technical Assistance** program, one of EDA's smallest programs in terms of funding, is nevertheless an extremely flexible and useful economic development tool. Projects analyze the feasibility of potential economic development projects, such as an industrial park or a high-technology business incubator. Feasibility studies are an effective tool for determining whether the market will support a particular activity or site.

While Local Technical Assistance investments are typically small in size and scope, they can prevent costly mistakes and misguided investments, such as costly infrastructure improvements to support obsolete industries. Targeted market feasibility studies can help communities overcome these hurdles and identify tomorrow's higher-wage employers. Because of these feasibility studies, many communities have subsequently received funding under EDA's Public Works or Economic Development Assistance programs, or other federal and state programs, to implement those projects.

The National Technical Assistance program assists in formulating and implementing new economic development tools. These tools support local governments' efforts to partner with private industry and attract private investment to revitalize regions and local communities. Providing timely information on best practices in economic development is critical to practitioners' efforts to alleviate economic distress and promote economic development. This program identifies and funds the collection and dissemination of new knowledge, analysis, and technical information, which helps communities assess their economic development opportunities and supports EDA's overall strategy of enhancing regional cooperation, fostering innovation, increasing productivity and developing industry clusters.

Research and Evaluation

Through the Research and Evaluation program, EDA builds the knowledge base for sound, market-driven regional and local economic development. This work is critical to ensure that EDA's initiatives and investments are consistent with current best practices in economic development. Program evaluations ascertain EDA's impact on measures such as return on taxpayer investment, private capital investment leveraged, and the creation of higher-skill, higher-wage jobs. Projects under the Research and Evaluation program may be carried out through grants or cooperative agreements, as well as through studies conducted in-house, to maximize the impact of this modestly funded program.

Trade Adjustment Assistance Program

Administered by EDA, the Trade Adjustment Assistance for Firms (TAAF) program helps economically distressed U.S. businesses develop strategies to compete in the global economy. Through a partnership with a national network of 11 EDA-funded Trade Adjustment Assistance Centers (TAACs), the program provides cost-sharing technical assistance to help eligible businesses create and implement targeted business recovery plans that are aimed at boosting global competitiveness, increasing sales, and retaining and creating jobs.

The TAACs, which are either independent or university-affiliated entities, provide support to import-impacted firms in a public-private collaborative framework. The TAAF program provides a portion of the assistance, while participating firms contribute a matching share to create and implement their recovery plans called Adjustment Proposals (APs).

In FY 2012, the TAAF program certified 79 petitions for certification of eligibility, and approved 102 adjustment proposals. Through both the in-depth analysis of each firm and the execution of recovery plans, distressed firms are given the opportunity to adjust to import pressures and become more competitive.

Alaska

During FY 2012, EDA awarded 19 grants totaling \$6.5 million throughout the state of Alaska. These investments support the state's bottom-up, regionally-owned economic development initiatives to create jobs and maximize their economic assets and potential. EDA invested in the state's efforts in growing its economy through deep sea fishing, marine service and repair facilities, fish processing, and disaster resiliency in both urban and rural communities, including native villages. EDA construction grants alone are expected to help create or retain 485 jobs.

Investment Spotlight: Marine Service Center Supports Local Fishermen

The mainstay of the Bering Sea economy is the fishing industry. Currently, fishing boats must travel 300 miles to Washington State to the nearest marine service and repair facility, a three day trip, for repair. Without a closer option for vessel repair, fishermen lose critical income while their boats are out of commission.

In 2012, EDA awarded \$1.8 million dollars to fund construction of a marine service, repair and supply center on St. Paul Island. A collaboration of the Aleut Community of St. Paul Island and the Central Bering Sea Fishermen's Association, the new service center will provide a home for essential support service and repair activities for vessels, enabling them to return to operation sooner. The facility will decrease costs for small fishing businesses operating throughout the Bering Sea, increasing their competitiveness. Local residents, including those of the Aleut Community, will have access to new jobs in vessel repair, service, and construction. As a result of the construction of this new center on St. Paul Island, the grantee anticipates growth of the seafood industry and expanded retail sales in marine segments. EDA's investment will help create 200 jobs and save 100 jobs.

Alabama

EDA awarded six grants in the state of Alabama totaling \$1.1 million. These projects support the state's network of Economic Development Districts as they build the foundation for long-term economic growth and prosperity and a university center project, which leverages applied research and technical assistance to help communities capitalize on economic development opportunities.

Investment Spotlight: Auburn University Helps New and Existing Businesses Grow

Institutions of higher education are critical players in the development of vibrant economic ecosystems. Universities have significant economic development assets—such as faculty, staff, students, research and proof of concept centers, laboratories, and high-speed broadband networks—to support regional economic growth.

In July 2012, Auburn University's Auburn Technical Assistance Center (ATAC) was selected as one of ten University Centers in EDA's eight-state Atlanta region. By leveraging the university's available resources, ATAC helps businesses, industries, and not-for-profit entities from across Alabama learn how to improve their competitiveness, optimize efficiency, and explore market expansions through a variety of educational and outreach services.

As an EDA University Center, ATAC is also providing its expertise to support winners of the Economic Development Partnership of Alabama's (EDPA) Alabama Launchpad competition. Alabama Launchpad provides a framework for entrepreneurs in the state to develop their business ideas and to connect with a network of experts, investors, and service providers. By providing unique opportunities to obtain startup capital, receive expert guidance, and establish working relationships within the business, academic, and investment capital communities, Alabama Launchpad is helping increase the odds of success for new entrepreneurs.

Arkansas

During FY 2012, EDA made 11 grants totaling approximately \$10 million throughout the State of Arkansas. After experiencing severe flooding in the spring of 2011, EDA responded by investing \$8.75 million in projects designed to help communities make their economies stronger and more disaster resilient. These projects include a wide-range of activities, such as rebuilding and improving vital infrastructure, providing workforce training, and encouraging trade and exports. By supporting growth in the state's tourism, aviation, and manufacturing industries, these investments are expected to create or retain 140 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Supports the Return of Tourism in Flooded Region

Following a significant loss of manufacturing jobs due to outsourcing, the economy of Van Buren County, Arkansas, has become heavily dependent on tourism. Located in the heart of the Ozark Mountains, the city of Fairfield Bay experienced significant flooding in 2011 which damaged the city's conference center and marina. The flooding forced numerous business closures and threatened the viability of additional businesses and amenities, all vital elements in attracting visitors to the region. Repair of the conference center and rebuilding essential infrastructure became imperative to restoring economic activity and jobs, as well as attracting new business investments to the region.

In September of 2012, EDA invested \$1.1 million to renovate the Fairfield Bay Conference Center and the construct essential road infrastructure. The completion of the project promises to create significant opportunities for jobs in tourism, marketing, and retail fields, as well as encourage new businesses and industries to locate and remain in the economically distressed area.

American Samoa

Following the closure of the majority of American Samoa's tuna canneries and damage from a 2009 tsunami, American Samoa began the process of developing a Comprehensive Economic Development Strategy (CEDS) to focus the Territory's economic recovery efforts. Funded by a grant from EDA, the CEDS process has allowed public and private sector leaders to assess the island's challenges, assets, and opportunities to develop a road map of actions that will lead to long-term sustainable growth. When fully implemented, the CEDS will help the Territory become more resilient to natural and economic disasters.

The White House and the Office of Insular Affairs at the Department of Interior, through the Interagency Group an Insular Affairs, are utilizing the CEDS process and its resulting strategies as a valuable tool in facilitating coordinated federal support for American Samoa and the other small U.S. Territories. CEDS provide an economic development framework, process, and strategy that supports private capital investment and job creation statewide. The CEDS process will bring together the public and private sectors in the creation of an economic development roadmap to diversify and strengthen the regional economy.

Arizona

During FY 2012, EDA awarded 10 grants throughout the State of Arizona totaling \$5.6 million. These investments encourage entrepreneurship, commercialization and disaster resiliency, support the growth of the aerospace and defense industries, and help position Arizona communities to maximize their economic assets and potential. These investments are expected to create or retain 300 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Supports Commercialization and Disaster Resiliency in Northern Arizona

A partnership of the Northern Arizona Council of Governments (NACOG), Northern Arizona University (NAU) and the City of Flagstaff, the Northern Arizona Center for Emerging Technologies (NACET) is a thriving business incubator servicing a variety of service, manufacturing, high technology, science and renewable energy firms. NACET also provides entrepreneurial outreach assistance to clients in the region, including the Navajo, Hopi, White Mountain Apache and San Carlos Apache Indian Tribes. Funded in part by a 2003 EDA investment, the NACET's Phase I building houses wet and dry lab space that incubate biotechnology and energy companies and fosters commercialization of technologies developed at NAU and in the region. As of 2012, NACET had generated \$109.7 million in private sector investment and helped to create 320 new high-skill, high-wage jobs in the more than 25 business that have been assisted by the incubator.

In 2012, EDA awarded \$4 million to fund construction of a Phase II business incubator to provide business assistance services for Phase I graduates to accelerate the commercialization of their products. The facility will also serve as an alternative emergency response center for first responders for the efficient delivery of services to communities and tribal nations during natural disasters, a critical community need exposed by extensive flooding in 2011. This EDA investment is expected to create 300 jobs and attract \$70 million in private investment.

California

During FY 2012, EDA awarded 25 grants totaling nearly \$18 million throughout the State of California. These investments support the growth of advanced manufacturing, entrepreneurship, export development, and disaster resiliency. EDA has also continued to invest in efforts to promote the commercialization of innovation throughout the state including UC Davis, a 2012 *i6 Challenge* winner, and the Clean Tech Incubator in Los Angeles. EDA construction investments made in FY 2012 alone are expected to help create or retain about 4,090 jobs in California.

Investment Spotlight: EDA Investment Enables Collaboration for Innovation

Los Angeles County has experienced double digit unemployment for years, and community and business leaders have collaborated to develop strategies to diversify the economy and leverage the assets of the region's premier institutions of higher education. Located on an entire city block in the heart of the Los Angeles Clean Tech Corridor, the Los Angeles Kretz Innovation Campus will serve as a hub for clean tech research and commercialization. Home of the Los Angeles Clean Tech Incubator, clean tech demonstration centers, R&D labs, conference facilities and workforce training facilities, the Innovation Campus will provide start-ups with direct access to state-of-the-art lab equipment, newly trained workers, and monthly research conferences and symposiums. The close proximity created by the campus environment will enable R&D professionals to enlist the help of entrepreneurs in bringing their inventions to market.

With EDA's investment, collaboration between groundbreaking researchers will now be as easy as walking down the hall. In 2012, EDA awarded a \$2.1 million grant to support the creation of the Los Angeles Kretz Innovation Campus. These funds will be used to construct two parking lots, build a solar power generation photo voltaic canopy structure, fund capital equipment for a laboratory, as well as a prototyping/training workshop in the incubator. EDA's investment is expected to create 171 new jobs.

Colorado

EDA awarded 11 grants in the state of Colorado totaling \$672,034. These projects support the state's network of Economic Development Districts as they build the foundation for long-term economic growth and prosperity and assist areas of the state impacted by severe weather.

Investment Spotlight: EDA's Investment Encourages Tourism in Fire Ravaged Region

In the summer of 2012, adverse weather conditions in Colorado led to a series of severe wildfires in the Colorado Springs area, causing widespread property damage and significant economic losses. The fires swept through the region during the height of the summer season, closing many hotels and attractions that are the mainstays of the local tourism-based economy which employs approximately14,000 workers. With extensive news coverage of the fires, the negative impacts to the region's tourism jobs lingered long after the fires subdued.

Lost business revenue and lost wages made it impossible for the area to recover without supplemental marketing to drive additional travel to the region over the remainder of the summer and fall travel season. In the wake of the fires, EDA worked with the Colorado Springs Convention and Visitors Bureau to help preserve critical tourism jobs. In September 2012, EDA awarded \$200,000 to help the Bureau fund an advertising campaign in print, electronic and social media targeted at encouraging tourists to return to the area, spurring recovery of the region's tourism industry.

Connecticut

During FY 2012, EDA awarded six grants totaling \$2.5 million in the State of Connecticut. These awards included a 2012 Rural Jobs and Innovation Accelerator Challenge winner that will catalyze job creation and leverage private capital across New England's agriculture industry. These investments are expected to create or retain 150 jobs according to grantee estimates.

Investment Spotlight: EDA Seeds Locally Grown Jobs

Accessibility and affordability of healthy, locally grown fruits and vegetables is a challenge faced by many communities nationwide. Not only does access to locally-grown food promote the health and well-being of all Americans, but strong regional food infrastructure creates new job opportunities for regional farmers and small businesses at every step in the food production chain.

Through the Administration's Rural Jobs and Innovations Accelerator Challenge, a funding opportunity offered by four federal agencies, EDA joined the U.S. Department of Agriculture in investing in the Wholesome Wave Foundation's New England Food Hub Initiative. EDA's \$367,600 grant will help the foundation address the demand for locally produced foods by providing technical business assistance and access to capital to food producers, processors, storage, and transporters throughout New England. Based in Bridgeport, Wholesome Wave will help start and expand new food hubs. These hubs will generate additional revenue to the region's farmers, as well as new jobs at every step in the food production chain from farming, to distribution, and production.

Washington, District of Columbia

During FY 2012, EDA collaborated with the Office of the Deputy Mayor for Planning and Economic Development to provide input and assistance with the City's Five-Year Economic Development Strategy for the District of Columbia. Published in November 2012, this plan is the District's first strategic roadmap for sustained, sector-driven economic development with the goals of creating 100,000 new jobs and generating \$1 billion in new tax revenue in the next five years.

In December 2012, the District of Columbia Office of Planning also released its DC Innovation Strategy for Saint Elizabeth's Final Report. Funded by an EDA grant in FY 2010, this report articulates how the City can leverage the decision of the Federal government to consolidate the Department of Homeland Security (DHS) at the site of the former Saint Elizabeth's hospital to transform the surrounding neighborhood into an Innovation Hub for the defense, intelligence and security industries. By converting the St. Elizabeth's campus into an integrated center of research, education, training, entrepreneurship, technology transfer, and private sector commercial activities, the City seeks to transform Ward 8, one of the City's most economically distressed areas, into the epicenter of a thriving regional innovation economy.

Delaware

EDA awarded two grants in the state of Delaware in 2012 totaling \$141,700. These grants provide a foundation for assistance for communities to develop locally-driven collaborative economic development strategies for long-term economic growth.

Investment Spotlight: EDA Planning Investment Leverages Assets to Transform a Local Economy

Over the past decade, Northern New Castle County has experienced dramatic economic shifts as many of its major manufacturers downsized or shuttered their factories. In order to create more and better employment opportunities for its residents, the County needed to transition from an economic base dependent on large corporations, banking, and chemical companies to a more diverse economy supportive of small businesses, manufacturers, and knowledge workers.

In April 2012, EDA awarded a \$41,700 technical assistance grant to New Castle County to formulate a business corridor plan for Routes 9 and 13, major thorough fares that have struggled with corporate restructuring and manufacturing plant closures. The strategic plan will assist the Port of Wilmington, New Castle Airport and Norfolk Southern freight rail to identify growth opportunities and industry clusters complementary to their services. EDA's modest investment will also enable New Castle County to identify opportunities for manufacturers and small and existing businesses to take advantage of strong transportation infrastructure, numerous potential redevelopment sites, and available workforce. By effectively leveraging available assets, local businesses will be able to increase distribution, serve new markets, and export more goods.

Florida

EDA awarded 12 grants in the state of Florida totaling \$5 million. These grants include a mix of planning, construction and networking assistance that support the growth of energy and high-technology industry clusters. These investments are expected to create or retain 1,800 jobs according to grantee estimates.

Investment Spotlight: EDA's Investment Accelerates Entrepreneurship in Tampa

Burdened with high unemployment, Florida's Tampa Bay Region needed to jumpstart its economy. The region's entrepreneurs faced the three-fold challenge of limited availability and access to early stage capital, a small pool of experienced tech executives, and difficulty attracting top talent to early-stage ventures. While the region possessed a complex network of universities, small business support centers, and other resources, these assets were not cohesively working together to accelerate innovation and entrepreneurship in West Central Florida.

A collaborative regional partnership—Tampa Bay FirstWaVE Venture Center—that includes the University of South Florida, Tampa BayWaVE, the Tampa Bay Technology Forum, the City of Tampa, Hillsborough County, and the University of Tampa will serve as a critical catalyst to innovation-based economic development in the region. A winner of EDA's FY 2012 *i6 Challenge*, FirstWaVE will connect existing regional entrepreneurship resources, mentors, capital, and industry expertise into a highly cohesive innovation ecosystem. EDA's \$1 million *i6* award supports FirstWaVE's 5-year Build-Launch-Grow accelerator framework which helps start-up companies secure the early-stage angel funding necessary to develop into viable tech companies. Building upon best practices of nationally recognized incubators, entrepreneurship centers, and accelerators, FirstWaVE seeks to create a model that can be replicated throughout Florida.

Georgia

During FY 2012, EDA awarded 10 grants in the State of Georgia totaling \$5.6 million. EDA invested in six Public Works projects that funded critical infrastructure —road improvements and rail spurs, increased sewer capacity, and installed fiber optic cable—that are helping communities across the state to support business expansion and the attraction of new industry. These investments are expected to create or retain 767 jobs according to grantee estimates.

Investment Spotlight: EDA-Funded Roadway Improvements Pave the Way to Job Growth

The city of Dalton, in Whitfield County, Georgia, was known as the "Carpet Capital of the World" for its many large and small carpet manufacturers. The sharp decline in residential and commercial construction during the economic downturn had direct negative impacts on the demand for carpet, leaving the carpet industry, and Dalton, particularly hard hit.

In 2012, EDA awarded Whitfield County \$1.4 million in Public Works funds to construct roadway improvements to a manufacturing area. This investment enables the location of an engineered wood floors plant in Dalton. The new facility leverages the workforce talent in the region and utilizes recycled materials in its production process to cut waste and reduce dependence on raw materials to help the company become more competitive in the global marketplace. The project is expected to create 250 jobs and generate \$65 million in private investment, according to grantee estimates.

Guam

Following a steep decline in economic activity caused by the continued downturn in international tourism; EDA funded a revitalization strategy in 2010 for the Territory of Guam. This led to the development of the Guam Comprehensive Economic Development Strategy (CEDS) which was published in 2011 as a collaborative effort between the Guam Economic Development Authority, the Bureau of Statistics and Plans, and the University of Guam Center for Economic Initiatives. The CEDS process engaged private sector stakeholders to address the need to diversify the economy and meet the challenges posed to island infrastructure and the business community by the proposed military build-up on the island as a result of the relocation of Marines from Japan to Guam. When fully implemented, the CEDS will help the Territory become more resilient to natural and economic disasters.

The White House and the Office of Insular Affairs at the Department of Interior, through the Interagency Group an Insular Affairs, are utilizing the CEDS process and its resulting strategies as a valuable tool in facilitating coordinated federal support for Guam and the other small U.S. Territories. CEDS provide an economic development framework, process, and strategy that supports private capital investment and job creation statewide. The CEDS process will bring together the public and private sectors in the creation of an economic development roadmap to diversify and strengthen the regional economy.

Hawaii

During FY 2012, EDA awarded eight grants totaling \$8.2 million to grantees in the State of Hawaii. These investments encourage the growth of alternative energy, biotechnology and ocean science, agriculture, tourism, culinary arts, commercialization and disaster resiliency in the state by supporting bottom- up, regionally-owned economic development initiatives to create jobs and position communities in Hawaii to maximize their economic assets and potential. These investments are expected to create or retain 987 jobs according to grantee estimates.

Investment Spotlight: EDA Supports Clean Energy Start-ups

Because of its remote location, Hawaii's economy is heavily dependent on imported oil. A profound understanding that lessening Hawaii's dependence on oil is critical to ensuring its economic stability has compelled the state, and its Natural Energy Laboratory of Hawaii Authority (NELHA), to become a leader of clean energy research and development.

With lowering foreign oil dependency a critical issue across the county, the economic benefits of clean energy innovations developed in Hawaii are having significant impacts far beyond the Islands. To harness growing demand and opportunity, NELHA needed to expand and upgrade its incubator to grow more startups, as well as provide them access to cutting edge technologies to increase their competitiveness. EDA's investment of \$3 million will fund the renovation and conversion of an existing business incubator into an alternative energy and biotechnology demonstration incubator. Located in NELHA's technology park in Kailua-Kona, the building will provide space for business tenants that have completed the research stage for their products but need further technological development and demonstration prior to commercialization. The project is expected to create 985 jobs, and further grow the state's clean energy cluster.

Iowa

In FY 2012, EDA grantees in Iowa received 19 grants totaling \$3.1 million. EDA's investments support the growth and expansion of bio-processing, alternative energy, and disaster recovery. By supporting bottom- up, regionally-owned economic development initiatives, EDA's investments will create jobs and position Iowa communities to maximize their economic assets and potential. These investments are expected to create or retain 165 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Provides Critical Gap Funding for Small Businesses in Need

Following a natural disaster, small businesses often face challenges long after the clean-up is complete. EDA's Revolving Loan Fund (RLF) Program has been utilized extensively in disaster-impacted communities where affected businesses need low interest financing to restore operations. In 2012, EDA provided a \$2.9 million award to recapitalize of an RLF managed by the East Central Iowa Council of Governments (ECICOG) to provide support to businesses in a region that continues to recover from devastating floods in 2008.

ECICOG's Revolving Loan Fund Business Assistance Program has increased the amount of gap financing capital available for local businesses in need. Ovation Networks, Inc., a young and innovative Wi-Fi solutions company, is one of many businesses in downtown Cedar Rapids affected by the 2008 flood disaster that has not only survived, but is now thriving because of ECICOG's assistance. At a crucial time, the ECICOG RLF provided Ovation a \$150,000 loan, making possible a \$365,000 investment in furniture and fixtures and providing needed working capital. The company has prospered and contributed to the community's recovery. It now employs 63 workers.

Idaho

During FY 2012, EDA awarded 12 grants totaling \$1.3 million throughout the State of Idaho. These investments encourage the growth of manufacturing, entrepreneurship, export development and disaster resiliency in the state. By supporting bottom- up, regionally-owned economic development initiatives, EDA's investments will create jobs and position Idaho communities to maximize their economic assets and potential. Growing its manufacturing cluster is one of the state's top priorities.

Investment Spotlight: EDA University Center Drives Productivity in Idaho

TechHelp is the EDA University Center in Idaho affiliated with Boise State University. In its role as a University Center, TechHelp assists manufacturers throughout Idaho improve productivity and grow revenue and profitability. With offices in Boise, Pocatello, and Post Falls, TechHelp specialists work in partnership with the state universities to provide assistance to manufacturers, food and dairy processors, service industry and inventors to strengthen their global competitiveness through continuous innovation for new and improved products, markets and processes.

TechHelp clients have achieved remarkable results: in FY 2012 alone, TechHelp helped 66 firms create 335 jobs. TechHelp-assisted firms have increased and retained sales totaling \$53.4 million, cost savings totaling \$10.6 million, and investments in plant modernization, equipment and people adding up to \$6.6 million.

One of the companies assisted by TechHelp is Rekluse, now the motorcycle industry leader in clutch performance and innovation. Founded in 2002, this small manufacturer has grown 31 jobs and exports \$400,000 worth of products a year. It has expanded its manufacturing capacity with a new location in the Boise area, and continues to grow with new products and markets. In 2012, the Small Business Administration named Rekluse its Small Business Exporter of the Year.

Illinois

During FY 2012, EDA awarded 20 grants totaling \$8.3 million in the State of Illinois. These investments spurred job creation in medical devices, IT startups, transportation and logistics, and high tech manufacturing. These projects leveraged the assets of the rural and urban areas of the state to create a holistic approach to economic development that is able to increase productivity, spur innovation and entrepreneurship, and increase long-term regional competitiveness and economic diversification. These investments are expected to create or retain 1,478 jobs according to grantee estimates.

Investment Spotlight: EDA Award Attracts Foreign Direct Investment

Rochelle, Illinois and surrounding counties are home to one of the Midwest's largest intermodal terminals and with millions of containers entering and departing every year. The region is home to many of the State of Illinois' major transportation routes including two Interstates (88 and 39), five U.S. highways, 11 State highways, 400 miles of rail serviced by two major railroads and two of Illinois' major waterways. Despite these advantages, since 1990, the region has shown net losses of manufacturing jobs, leading to an increased numbers of households living in poverty.

With more than 80 million people in 15 states and Canada accessible in less than 24 hours, Rochelle's transportation assets present tremendous opportunities for manufacturers. To help the region capitalize on its strategic location, EDA awarded Rochelle \$2.4 million to fund improvements to the Rochelle Dual Access Railroad. The upgraded rail line will allow for more efficient connections to the nearby main lines of the Union Pacific and Burlington Northern Santa Fe Railroads.

The improved short-line railroad services a manufacturing facility for Nippon Sharyo U.S.A., the U.S. subsidiary of a Japanese manufacturer of railcars. By providing a vital rail spur connection to connect to major railroad lines, EDA's investment encouraged Nippon Sharyo to build a new, larger facility in Rochelle. Nippon Sharyo has a long history of selling passenger railcars here in the United States. With the opening of this new plant in Rochelle, however, the company will be able to expand its U.S. operations, lower production costs, comply with the "Made in America" requirements of many of its buyers, and—most important to the economy here—create 250 new jobs.

Indiana

In FY 2012, EDA grantees in Indiana received seven grants totaling \$6.9 million. Following significant losses in jobs and the manufacturing base, EDA's investments support the growth and expansion of industrial parks across the state, as well as the development of a strategy for the reuse of four closed auto plants. By supporting bottom- up, regionally-owned economic development initiatives, EDA's investments will create jobs and position Indiana communities to maximize their economic assets and potential. These investments are expected to create or retain 1,580 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Sparks Development in Energy Storage Innovation

Much of southern Indiana has experienced considerable manufacturing loss over the past decade. Counties in the region have been working hard to formalize plans for restructuring and moving forward beyond these employment losses, but coordination and implementation have proven difficult.

In September 2012, EDA announced Southern Indiana Development Commission (SIDC) and the Battery Innovation Center, Inc. (BIC) as winners of its FY 2012 *i6 Challenge*. This winning project focuses on the development of entrepreneurial opportunities resulting from the rapid development, testing, and commercialization of safe, reliable, and lightweight energy storage systems for commercial and defense customers. Based on the innovation in battery research conducted at the Crane Naval Surface Warfare Center in conjunction with engineering and business expertise at Purdue University, Pennsylvania State University, Indiana University-Purdue University Indianapolis, University of Notre Dame, and the Ivy Tech Community College, this \$1 million EDA investment supports the development of a proof of concept center which is anticipated to support the development of a number of new technology start-ups and an increase in manufacturing in the region.

To create new business opportunities, local leaders are seeking to capitalize on Crane's role as a key regional employment driver. BIC is providing strong benefits not only to the Department of Defense, but also important commercial opportunities. The Center also present opportunities to

entice new high-tech, high-wage DoD contract employers to locate within the region, strengthening the energy storage cluster and creating new job growth opportunities.

Kansas

EDA awarded 10 grants totaling \$3.6 million in the State of Kansas during FY 2012. These grants funded construction projects that support manufacturing, diversify the agriculture sector, provide technical assistance to communities, and encourage strategic planning. These projects are expected to create or retain 355 jobs according to grantee estimates.

Investment Spotlight: EDA's Infrastructure Improvements Enable Aircraft Assembly Expansion

Wichita, Kansas is an internationally recognized center for aeronautics industry research and development and aircraft production. With companies including Beechcraft, Bombardier, Cessna, and Airbus have all located manufacturing facilities in Wichita, the aircraft assembly industry cluster, with a large number of high-skill, high-wage jobs, is a leading exporter of aircraft to customers worldwide. However, Wichita's heavy reliance on the aircraft industry meant that the community was especially impacted by the sharp decline in aircraft orders during the global recession of 2008-2010. At its peak, layoffs in the Wichita area impacted more than 12,000 aircraft production workers.

In 2011, Bombardier Learjet notified the Wichita Airport Authority of its need for additional space for a major expansion of its manufacturing operations to accommodate production of the new Learjet 85 aircraft, as well as a new Center of Excellence for Engineering and Information Technology. Because Bombardier was totally landlocked, the only option for expansion was for the Airport Authority to relocate a parking structure to free up land adjacent to the Bombardier facility. In FY 2012, EDA awarded nearly \$2 million to help the airport authority for the removal of the existing parking facility and to rebuild it in a different location. This investment, coupled with \$1 million invested by both the City and Sedgwick County respectively, will leverage Bombardier's private investment of \$600 million to expand its Learjet production in Wichita. Bombardier's expansion is expected to add 450 high-paying jobs over the next seven years.

Kentucky

EDA awarded 11 grants totaling \$12.5 million in the Commonwealth of Kentucky in FY 2012, six of which were disaster recovery grants for affected communities recovering from flooding. Additionally, the University of Kentucky renewed its status as an EDA University Center in the 2012 Atlanta Regional Office University Center competition. These investments are expected to create or retain 2,093 jobs according to grantee estimates.

EDA Investment Increases Statewide Coordination for Economic Development

The Commonwealth of Kentucky has made impressive strides in economic development in recent years, making Kentucky a leader in new industry attraction and expansion. In 2012, exports from Kentucky reached a record \$22.1 billion with products and services going to 199 countries and the Commonwealth ranked 10th in Site Selection magazine's annual Governor's Cup award, recognizing the highest number of qualifying industry locations and expansions.¹

At the heart of the Commonwealth's economic development efforts is a strong network of fifteen Area Development Districts that comprise a statewide network of multi-county planning and development organizations. These Districts provide critical support to local governments and serve as forums, clearinghouses, technical centers and as conveners for their respective regions. However, to more effectively leverage the Districts' work, the Commonwealth needed to develop and implement strategies for the ADDs to coordinate their Comprehensive Economic Development Strategies (CEDS). CEDS provide an economic development framework, process, and strategy that supports private capital investment and job creation statewide. The CEDS process will bring together the public and private sectors in the creation of an economic development roadmap to diversify and strengthen the regional economy.

Louisiana

During FY 2012, EDA made 10 grants totaling approximately \$7.6 million throughout Louisiana to help the state become more disaster resilient and support sustainable, green economic growth. These EDA investments support the continued growth of regional biofuels and clean technologies industry clusters and increased disaster resiliency for communities that have suffered from continued flooding events allowing them to attract and retain business in the local economy. Disaster recovery investments also include technical assistance needed for business to recover quickly after a natural disaster. According to grantee estimates, the investments in Louisiana will create or retain 72 jobs.

Investment Spotlight: Private-Public Partnerships Build a Stronger, More Diverse Economy in New Orleans

The City of New Orleans has made tremendous progress in recovering from the devastating effects of Hurricanes Katrina, Rita, Gustav, Ike, and Isaac. With good strategic planning and strong collaboration between the public and private sectors, the economy of New Orleans is emerging stronger and more diverse than before the storms.

A public-private partnership between the City of New Orleans and the private sector, the New Orleans Business Alliance is the newly formed group helping the city grow and develop after Hurricane Katrina. In 2012, EDA invested \$1 Million in the New Orleans Business Alliance to fund the development and implementation of a strategic plan to boost business and job growth in the city. The study will help the Alliance identify top sectors and opportunities for long-term job growth, outline strategies for developing those sectors, and present a unified economic development agenda that highlights New Orleans' unique strengths as well as opportunities to enhance the city's competitiveness. The strategic plan is already well underway. The Strategic Advisory Council has identified several cluster-specific areas of growth for the city. The five clusters are Advanced Manufacturing; BioInnovation and Health Services; Creative Digital Media; Sustainable Industries; and Transportation, Trade & Logistics.

Massachusetts

During fiscal year 2012, EDA awarded 15 grants totaling \$2.7 million. These grants support ongoing strategic economic development designed to bring together the public and private sectors in the creation of an economic development roadmap to diversify and strengthen the regional economy. These investments are expected to create or retain 645 jobs according to grantee estimates.

Investment Spotlight: EDA Construction Investment Promotes Growth of Life Science Cluster

Located in southeastern Massachusetts, Myles Standish Industrial Park in Taunton is a sprawling industrial campus hosting a diverse array of 100 companies employing approximately 7,400 residents of southern Massachusetts and northern Rhode Island.² Despite high market demand for space in the Park which would provide new business growth opportunities, the Park lacked the infrastructure it needed to expand.

With southeastern Massachusetts fighting high unemployment rates, local officials needed to capitalize on this critical growth potential. In May 2012, EDA awarded \$1.6 million to the City of Taunton and the Taunton Development/ MassDevelopment Corporation to begin the \$3 million Phase IV expansion of the Park. This EDA-supported project has helped construct six construction-ready sites for new industrial development. With Phase IV nearly complete, the Park is now able to embark on a Phase V expansion to host the City's Life Sciences Center. This newest development will support the state's long term goal of expanding life science-related educational and job placement opportunities in southeastern Massachusetts. Market analysis indicates that Phase IV alone is expected to provide 466 new full-time jobs, while full build out of Phases IV and V can facilitate nearly 2 million square feet of space for business and industry and the potential to host 2,200 job slots.

Maryland

During FY 2012, EDA continued its support of Maryland's three economic development districts and university center by awarding four grants totaling \$360,000 to EDA's partners. These grantees help communities across the state develop, maintain, and implement strategic economic development plans. These bottom-up, locally driven approaches provide the state a roadmap to sustained growth and job creation.

Investment Spotlight: EDA Investment Creates an Emerging Entrepreneurial Environment

Co-working spaces for entrepreneurs is a concept that has proven to be very successful in many urban communities across the country. By providing entrepreneurs and new small businesses access to lower cost, flexible workplaces, co-sharing sites help to create a thriving entrepreneurial environment that promotes collaboration.

Despite this model's track record of success, rural entrepreneurs historically have had limited access to these opportunities. With \$120,000 in assistance from EDA, the Mid-Shore Regional Council EDD, in partnership with the Eastern Shore Entrepreneurship Center, created hotDesk.org. With two locations planned in rural Eastern Maryland, hotDesk.org will coordinate and encourage activities that accelerate the development of companies that apply new concepts and technologies in innovative ways by establishing virtual and physical networks of co-working spaces throughout the region where participating members can work, meet with clients, access professional and obtain technical resources and communicate with like-minded peers. Included in the regular scheduled events and programs will be events targeted at encouraging innovation and creativity. hotDesk.org will also assist and support regional incubators and accelerators.

Maine

During FY 2012, EDA awarded 13 grants totaling more than \$6.2 million throughout the State of Maine. These investments encourage the growth of advanced manufacturing and multi-modal transportation businesses, the redevelopment of blighted and non-productive commercial properties, strategic planning and the recovery of the commercial fishing industry. These grants will assist both urban and rural communities in achieving their bottom- up, regionally-owned economic development initiatives. These investments are expected to create or retain 453 jobs according to grantee estimates.

Investment Spotlight: EDA Infrastructure Investment Enables Riverfront Redevelopment in Portland

With a metropolitan area that includes more than a third of the state's population, the City of Portland, Maine is the state's largest city. With a history dating back to 1633, Portland has a long heritage as a maritime, manufacturing and financial center, and is recognized as the economic engine of the state.

Like many historic cities, Portland faces a shortage of developable and re-developable space to accommodate new business growth in this vibrant and desirable community. A 27-acre, long-blighted parcel of riverfront commercial property known as Thompson's Point provides an opportunity to overcome these challenges. Known as the Forefront, the proposed redevelopment will include a professional sports and performing arts venue, conference center, commercial and medical office complex, and access to Portland's multi-modal transportation center. The Forefront will also serve as a modern, visually-impressive gateway that welcomes 3.6 million tourists each year, and reflects the city's vibrancy and crucial role in Maine's economy. In 2012, EDA awarded \$1.5 million for access, roadway and safety improvements to the Thompson's Point project. This project is expected to create 455 new jobs and leverage more than \$105 million in private investment.

Michigan

During FY 2012, EDA awarded 11 grants totaling \$4.5 million in the State of Michigan. These investments spurred job creation in the lumber/timber industries, medical devices, green energy, and high tech manufacturing. These projects leveraged the assets of the rural and urban areas of the state to create a holistic approach to economic development that is able to increase productivity, spur innovation and entrepreneurship, and increase long-term regional competitiveness and economic diversification. These investments are expected to create or retain 1,188 jobs according to grantee estimates.

Investment Spotlight: EDA Project Helps Region Capitalize on Export Opportunities

With close proximity to Canadian land crossings at Sault St. Marie and Port Huron, Eastern Michigan and the Upper Peninsula are uniquely positioned to accelerate export activity. However, to more effectively leverage this unique competitive advantage, the region needs a globally-competitive export strategy focused on creating new markets for local products and services.

In FY 2012, EDA invested \$332,365 to support the development of regional innovation exporting strategies that will help Michigan's regions assess and assist with the growth of exporting for the state's small and medium businesses. A collaboration between Michigan State University, East Michigan Council of Governments, Eastern Upper Peninsula Planning and Development Commission, and St. Clair County EDC, this project will also provide exporting data analysis; assist regional companies recognize and increase exporting opportunities; expand regional exporting strategies; and convene bi-national exporting conferences and partnerships. The purpose of the project is to assist Michigan communities and companies in competing successfully in the global marketplace by exporting and/or importing goods to and from Canada, as well as overseas markets. By increasing trade, the region's businesses will be able to grow and expand their workforce.

Minnesota

During FY 2012, EDA awarded 10 grants totaling \$2.1 million in the State of Minnesota. These investments spurred job creation in the agribusiness, transportation and logistics, mining, and IT startups. These projects leveraged the assets of the university and technical college system and the rural and urban areas of the state to create a holistic approach to economic development that is able to increase productivity, spur innovation and entrepreneurship, and increase long-term regional competitiveness and economic diversification. These investments are expected to create or retain 137 jobs according to grantee estimates.

Investment Spotlight: Critical Infrastructure Improvements Add Jobs in Southwest Minnesota

The City of Dawson is a small, rural community located in southwestern Minnesota. The State of Minnesota Demographic Center projects this region of southwest Minnesota's population to decline by 15% from 2010 to 2035, continuing a trend that began in the 1940's. In 2010 alone, in addition to other closures, an agricultural processor was forced to reduce its workforce by 90% because the City could not provide adequate wastewater treatment services. It was also determined that it was not possible to locate additional business within the City's industrial park due to aging and inadequate road, water, and wastewater infrastructure.

To stem the population and employment decline, the community recognized it needed to enhance its industrial base. In FY 2012, EDA awarded \$1,189,500 to the City of Dawson to fund critical improvements to its existing industrial park and to construct a new 65-acre industrial park nearby. This project includes the construction of a new service roadway, new water mains, as well as a storm sewer and wastewater systems. Together with the immediate creation of 20 new jobs at a meat processing facility currently operating in the park, the City estimates that over the next nine years, the EDA investment will result in the creation of a total of 137 new jobs and \$35,000,000 in private investment.

Missouri

During FY 2012, EDA awarded 29 grants in the State of Missouri totaling \$5.4 million. These projects support infrastructure, workforce development, disaster recovery and strategic economic planning. EDA's investments support bottom- up, regionally-owned economic development initiatives that will create jobs and position Missouri communities to maximize their economic assets and potential. These investments are expected to create or retain 215 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Brings Entrepreneurship Opportunities

The Kansas City region has gained a competitive advantage in a number of information-technology industry sectors. The data processing, hosting and related services sector is forecasted to add hundreds of jobs over the next five years in the region. Telecommunications also has a strong cluster in the Kansas City area with Sprint's headquarters located here. In recent years, however, the area lost more than 8,000 telecommunication jobs between 2006 and 2011. Forecasts over the next five years call for continued losses, although at a reduced rate. These highly-skilled displaced workers could, with some training, start their own businesses or work for young businesses in the industry.

In FY 2012, EDA selected a business-civic consortium led by University of Missouri at Kansas City (UMKC) as a winner of the *i6 Challenge* competition. Developed through collaboration with corporate partners including Sprint, Hallmark and Time Warner Cable, as well as the Ewing Marion Kauffman Foundation, the initiative, called the Kansas City Digital Sandbox, brings to the region a new process for technology commercialization by clustering digital innovation resources into a central hub that has become a connection point for large businesses, emerging enterprises and entrepreneurs to jointly develop new products and services.

The Digital Sandbox addresses two critical needs of a vibrant entrepreneurial ecosystem in Kansas City: the need to connect the R&D resources of the area's major corporations into the region's entrepreneurial and university research networks; and the need for access to early-stage proof-of-concept support to allow startup technology ventures. Consortium leaders anticipate that the Digital Sandbox will generate a minimum of 10 new high-growth companies with either follow-on funding or at least \$1 million in revenue each within two years of the launch.

Mississippi

EDA awarded nine grants totaling \$4.7 million to recipients in the State of Mississippi during Fiscal Year 2012. These investments will help Mississippi communities advance their regionally developed economic development strategies by implementing projects that support the development of medical research and advanced manufacturing. These grants also include a new University Center award to Mississippi State University to provide technical assistance and research and development tools to increase productivity, spur innovation, and promote entrepreneurship to help increase long-term regional competitiveness and economic diversification. These investments are expected to create or retain 616 jobs according to grantee estimates.

Investment Spotlight: EDA Challenge Winner Accelerates Cluster Development in Rural Mississippi

Between 2006 and 2011, the State of Mississippi endured plant closures and job losses in three of its key industry clusters: agriculture, automotive, and furniture manufacturing.

Mississippi State University (MSU), working with a diverse group of internal and external partners, was awarded \$500,000 from EDA through 2012 *The Rural Jobs and Innovation Accelerator Challenge*. Focusing on Mississippi's Appalachian and Delta regions, MSU identified critical needs in 61 of the state's most rural and economically distressed counties. With additional funding provided by federal agency partners the US Department of Agriculture, Appalachian Regional Commission, and the Delta Regional Authority, MSU's project advances four core goals: strengthening communities, expanding clusters, growing companies, and developing entrepreneurs.

By working directly with prospective entrepreneurs, MSU will find and develop linkages among the region's small existing businesses and entrepreneurs and the region's strategic clusters. The project will also identify strong growth prospects from the region's existing industries. The proposed program targets the creation and retention of over 500 jobs, with an accompanying economic development impact of over \$30 million including private investment and cost savings.

Montana

EDA awarded 28 grants totaling \$3.8 million in the State of Montana in FY 2012. These grants supported technical assistance, strategic planning, and construction of essential infrastructure that supports growth of the private sector. These grants provide a foundation for assistance for communities to develop locally driven collaborative economic development strategies for long-term economic growth. These investments are expected to create or retain 152 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Creates High Skill Job Opportunities in Tribal Communities

Innovation in energy development in the Northern Plains presents new economic development opportunities in Montana and North Dakota. With potentially billions of gallons of previously untapped oil reserves now accessible, the Bakken shale formation has made one of the most rural regions of the country one of the most attractive to investors and developers, and become a thriving center for new business creation.

In no place have these newfound economic opportunities had a more profound impact than the region's remote tribal communities where high unemployment is chronic and persistent and new business creation opportunities are limited. In March 2012, EDA awarded \$1,000,000 to the Fort Peck Assiniboine & Sioux Tribes of Montana to help expand the Tribe's oil drilling services operations. EDA's investment funds the renovation and expansion of an existing building and the purchase of specialized equipment for the development of a tribally-owned pipe rethreading operation at Fort Peck Tech Services. As a result, the Tribe's entrance into the oilfield services industry is creating new high-wage, higher-skilled jobs that can be sustained for decades.

North Carolina

During FY 2012, EDA awarded 18 grants totaling \$7.3 million in the State of North Carolina to support economic growth and development through workforce development for its manufacturing cluster, leveraging the strength and opportunities of its agricultural industry cluster, and maximize communities' abilities across the state to develop strategies that support long-term local driven economic growth. These investments are expected to create or retain 494 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Repositions Local Economy for Emerging Industries

Richmond and Scotland counties are rural communities located in North Carolina's south-central Piedmont. This region has experienced economic distress for many years as its three traditional economic engines – trains, textiles and tobacco – have contracted or relocated out of the region. However, as these traditional industries continue to fade, new job opportunities are developing across North Carolina from the state's emerging energy production and transmission cluster and high tech manufacturing.

In an effort to position the south-central Piedmont as a hub for these emerging technologies, EDA awarded \$2,038,364 to fund the expansion and renovation the Forte Building on the Richmond Community College Campus. The upgraded facilities will serve as a state-of-the-art, high-tech training hub for science, technology, engineering and math (STEM) related fields. The project will train skilled workers to meet the future needs of North Carolina's advanced manufacturing and energy production/transmission industries, creating sustainable opportunities for the future. Grantees estimate that this EDA award will create 435 jobs and generate \$35,000,000 in private investment across the region.

North Dakota

EDA awarded 15 grants totaling \$2.5 million in the State of North Dakota during fiscal year 2012. These projects supported disaster recovery, technical assistance, and strategic planning allowing communities across the state to develop bottom- up, regionally-owned economic development initiatives. EDA's investments will create jobs and position North Dakota communities to maximize their economic assets and potential for long term economic growth. These investments are expected to create or retain 146 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Helps to Preserve Flood-Prone Town

The city of Minnewaukan, situated on the western shore of Devil's Lake in north-central North Dakota, is the economic and tourism hub of its region and for the neighboring Spirit Lake Nation. Over the last 18-years, the water levels in Devil's Lake have continued to rise, inundating the town and threatening City water and sewer services to 300 residents and jeopardizing businesses in the downtown. By 2010, it was clear that a significant portion of the community needed to be relocated to a new town site on higher ground out of the flood-threatened areas.

In FY 2012, EDA provided a disaster relief award of \$1.3 million to fund the construction of a new water line, distribution system, and access roads for displaced businesses and a school in Minnewaukan. This infrastructure will allow critical civic and business relocations to the new town site to proceed. With EDA assistance, the community's very existence is preserved, allowing Minnewaukan to maintain its important role in the region.

Nebraska

During 2012, EDA continued its support of its nine economic development districts, in Nebraska which maintain regional comprehensive economic development strategies. These strategies form the foundation and road map for long-term economic growth.

Investment Spotlight: EDA Planning Focuses on Community Successes to Build Foundation for Growth

West Central Nebraska Development District (WCNDD), headquartered in Ogallala, Nebraska provides economic and community development support for communities in 18 counties. With annual support through EDA's Partnership Planning Program, WCNDD formulates and maintains a comprehensive economic development strategy for the region it serves. Each community in the region is encouraged to participate in the strategic planning process. WCNDD uses the appreciative inquiry model that concentrates on community successes in order to determine what is necessary to move forward. To date, 29 communities have participated in strategic planning. In FY 2012, the support from EDA was \$61,000.

On an on-going basis, WCNDD has been able to utilize the EDA's Partnership Planning grants to implement a micro-business incubator program, a nuisance abatement program, a GIS program, and a business incubator. It has also assisted with business expansions in areas ranging from telecommunications to wind energy. EDA currently supports eight multi-county economic development districts across Nebraska.

New Hampshire

During FY 2012, EDA awarded eight grants totaling \$3.1 million throughout the State of New Hampshire. These investments encourage growth in general manufacturing and alternative fuels, military base and industrial facility redevelopment, business and workforce training and strategic planning. These projects are regionally-owned economic development initiatives to create jobs, encourage private investment, support successful entrepreneurship and return non-productive facilities to economic use. These investments are expected to create or retain 700 jobs according to grantee estimates.

Investment Spotlight: EDA's Investment Helps Attract and Retain Young Talent

Outmigration of talented young people is a challenge facing many small towns across America as a lack of a locally available workforce can have a profound impact on a region's ability to grown and attract new businesses. With young adults leaving in above-average numbers for jobs outside the region, Plymouth, New Hampshire, needed to develop new employment and entrepreneurial opportunities that would keep homegrown talent in the state.

In 2012, EDA invested \$781,000 to help fund construction of business incubator facility in downtown Plymouth. Operated by Plymouth State's Small Business Institute, the Enterprise Center is a true public-private partnership designed collaboratively to encourage and support successful entrepreneurship. An initiative of the Grafton County Economic Development Council, the Enterprise Center will accommodate up to ten tenant and 20 non-tenant businesses and is expected to launch in 2013 with a focus on "green business." EDA's award is matched by the Northern Border Regional Commission, the State of New Hampshire and contributions from nine private businesses. This project is expected to create 75 new jobs in its first three years of operation.

New Jersey

EDA awarded four grants totaling \$2.3 million in the State of New Jersey in FY 2012. These grants provided funding for infrastructure, workforce development, planning, and technical assistance helping New Jersey communities develop or implement bottom-up economic development strategies. These investments are expected to create or retain 217 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Expands Training Opportunities for Workers

Job development and training programs for job seekers have long been absent in Camden, New Jersey. Despite high demand for workers and numerous vacancies in entry level automotive opportunities, the pressures to link low-skilled workers with available jobs remains a challenge. Respond, Inc., a voluntary, not-for-profit agency created by community residents to enhance and promote the economic independence and general welfare of individuals and families residing in Camden City and county, has risen to this challenge.

Taking advantage of opportunities to rededicate this portion of the workforce, Respond, Inc. established an automotive technology program that not only trains residents, but supplies key workers to a vibrant industry cluster in and around the City of Camden. Within two years of opening, the New Worker Job Development Center's Automotive Technology training program has placed over 88 graduates into automotive positions within and outside the City. Almost 11% of graduates have started their own automotive repair businesses. A testament to the success of this program and the quality of its automotive technicians, General Motors will supply the Center with Cadillac technology to train students on testing and servicing of the Cadillac Escalade.

Due to the Center's strong performance metrics during its first two years, EDA awarded \$640,000 to Respond, Inc. for expansion of the Center's Automotive Training Facility in 2012. These expanded facilities will accommodate three car lifts, a garage entrance lift, and space for repair and training equipment. In addition to the federal support from EDA, Respond, Inc. has demonstrated that collaborations are key to success with donations coming from a range of private entities such as and Campbell's Soup, Holman Enterprises, the Toyota Motor Company, and General Motors.

New Mexico

During FY 2012, EDA invested \$2.2 million in four projects to create jobs and leverage private investment in the State of New Mexico. Projects in New Mexico will help state leaders undertake statewide economic development planning; nurture business associated with the growing cultural and arts industries; encourage small business growth and education in rural, economically distressed Northern New Mexico; and establish a proof of concept center.

Investment Spotlight: EDA Investment Promotes Access to Seed Capital for New Entrepreneurs

Southeastern New Mexico and far western Texas have a wealth of high-tech assets, including research universities; government facilities for defense and space/aerospace; medical research centers; and high-tech companies. However, these resources are currently not being used to their greatest advantage. A lack of coordination between players, diminished availability of private investment capital, and lack of awareness of entrepreneurial opportunities leads to missed opportunities for research commercialization and, ultimately, economic growth. To address this challenge New Mexico State University's College of Engineering and a closely-connected network of partners – researchers, government officials and policymakers, investors, entrepreneurs, and economic development specialists have joined forces to build a regional innovation pipeline and address current gaps in economic development infrastructure.

The Las Cruces-based Arrowhead Center's Arrowhead Innovation Network (AIN), a winner of EDA's 2012 *i6 Challenge*, is accelerating commercialization of regional research and building a sustainable entrepreneurial and innovation environment in southern New Mexico and west Texas. AIN is utilizing Launch, Arrowhead Center/NMSU's recently-created proof of concept program, to provide researchers with innovative, early-stage technology access to seed funding and commercialization services and support. AIN is expanding on existing Launch programming and introducing new initiatives to strengthen the proof of concept program and to enhance the regional innovation ecosystem as a whole.

Northern Marianas

In 2008 the Northern Mariana Islands Governor's Office received an EDA grant to develop a Comprehensive Economic Development Strategy (CEDS) to guide the islands to long-term sustainable economic growth. The Northern Marianas CEDS process engaged local stakeholders to address the challenges and opportunities presented by the normalization of Federal immigration and minimum wage. The CEDS was published in 2009 and as a result of these planning efforts, EDA funded two public works projects to improve water infrastructure for the tourism industry. Conversations are underway for the development of a new CEDS.

The White House and the Office of Insular Affairs at the Department of Interior, through the Interagency Group an Insular Affairs, have embraced the overall CEDS process and its resulting strategies as a valuable tool in facilitating coordinated federal support for the Northern Marianas and the other small U.S. Territories. CEDS provide an economic development framework, process, and strategy that supports private capital investment and job creation statewide. The CEDS process will bring together the public and private sectors in the creation of an economic development roadmap to diversify and strengthen the regional economy.

Nevada

During FY 2012, EDA awarded six grants totaling \$5.3 million throughout the State of Nevada. These investments encourage the growth of research and commercialization, life sciences, information technology, clean energy, advanced manufacturing, entrepreneurship, export development and disaster resiliency. By supporting the bottom- up, regionally-owned economic development initiatives, these investments are helping to create jobs and position Nevada communities to maximize its economic assets and potential. These investments are expected to create or retain 1,048 jobs according to grantee estimates.

Investment Spotlight: EDA Construction Project Diversifies the Reno-Tahoe Economy

Historically, the economy of the Reno-Tahoe region of Nevada has been very dependent upon tourism, including gaming, as well as housing and construction. This heavy reliance on economically sensitive industries made the area especially vulnerable to recession and slower to recover than much of the U.S.

Reeling in the wake of the recent economic downturn, Reno-Tahoe leaders renewed the region's efforts to diversify its economy. Key to these efforts is capitalizing on Reno-Tahoe's existing science and technology assets such as the Dandini Research Park, Desert Research Institute, the University of Nevada-Reno, Truckee Meadows Community College, as well as its significant tech businesses. In FY 2012, EDA awarded \$2.9 million to fund roadway infrastructure at the Dandini Research Park to support the development of the Collaborative Core and Upper Partnership Zone. This project will help create higher-wage, higher-skill research jobs, bolstering clusters such as clean tech, advanced manufacturing, information technology, and life sciences, which will significantly help rebuild the region's economy. The project is expected to create 900 jobs.

New York

During FY 2012, EDA awarded 21 grants totaling \$5.4 million throughout the State of New York. These investments promote growth in the manufacturing, agri-business, medical devises, and transportation industry clusters. These awards will help address areas experiencing economic distress in both urban and rural regions of the state. These investments are expected to create or retain 486 jobs according to grantee estimates.

Investment Spotlight: EDA Award Expands Agribusiness in Upstate New York

The favorable climate, fertile soil, and ample clean water of Finger Lakes region has made it the heart of a productive and growing agriculture cluster across Upstate New York. Centrally located in western New York, Genesee County is within a ten hour drive of 125 million Americans making it an ideal location for food processing and advanced manufacturing. Unfortunately, the limited capacity of Genesee County's water system was stymying growth of current and prospective agri-businesses in the region.

EDA responded in 2012 by investing \$1 million to fund critical infrastructure improvements to the Genesee County aquifer system at the Genesee Valley Agri-Business Park (GVAB). By providing immediate access to the aquifer, both new and existing agribusinesses have access to affordable water critical for the manufacturing various food products, as well as the increased capacity they need to expand their operations. The development of the GVAB will have significant regional breadth, boosting the region's economy by adding, over the long term, nearly 1,200 jobs across the region helping foster economic stability and enhanced social viability. This project will open 200 acres of "build ready" sites and is expected to create 186 direct jobs and leverage \$206 million in private investment.

Ohio

During FY 2012, EDA awarded four grants totaling \$5.9 million in the State of Ohio. These investments spurred job creation in transportation and logistics, IT start ups, automotive technologies, and high tech manufacturing. These projects leveraged the assets of the major urban areas and the major universities of the state to create a holistic approach to economic development that is able to increase productivity, spur innovation and entrepreneurship, and increase long-term regional competitiveness and economic diversification. These investments are expected to create or retain 1,570 jobs according to grantee estimates.

Investment Spotlight: EDA Award Increases Export Potential of Southern Ohio

Located on the Ohio River at the southernmost point of the state, Lawrence County, sits at the confluence of the Ohio, West Virginia, and Kentucky tri-state region. With accessibility to the deepwater Huntington Port, close proximity to rail via the Norfolk Southern Heartland Corridor and an excellent highway system, the County's geography and strong transportation infrastructure gives it a unique competitive advantage.

In FY 2012, EDA awarded \$2,935,839 to construct a rail spur and six rail switches to connect the Point Industrial Park in Lawrence County to the Norfolk Southern Heartland Corridor railroad, transforming the Park into a multi-modal facility that will provide an additional key access point to the heart of the Ohio River Valley. The Park's prime location on both the Ohio River and the main Norfolk and Southern rail lines, provides a unique opportunity for containers originating or terminating in Norfolk, Virginia to be transferred to or from barges along its direct river access. As a result, Park tenants will have access to international shipping advantages, allowing goods to travel easily for import or export from both the East and West Coasts and overseas. The increased rail access provided by EDA's investment will enable three companies that currently operate in the Park to expand, creating an additional 186 new jobs, and 500 jobs will be retained.

Oklahoma

During FY 2012, EDA awarded 13 grants totaling \$8.95 million throughout the State of Oklahoma. These investments encourage the growth of advanced manufacturing and transportation in the state and support the growing oil and gas, aeronautics, medical device, and high technology industry clusters. These grants will help both urban and rural communities achieve their bottom- up economic development initiatives. EDA's investments in the State of Oklahoma are expected to result in the creation or retention of 623 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Leverages Transportation Assets

Blackwell, Oklahoma, is located in the middle of the United States near primary shipping corridors, immediately adjacent to Interstate 35 with direct access to Oklahoma City, Tulsa, Dallas, Wichita and Kansas City. In addition to over-the-road service, BNSF and Union Pacific rail via local short-line rail service provided by the Blackwell Northern Gateway Railroad connects Blackwell to domestic and international markets including those available through the Tulsa Port of Catoosa, one of the nation's most in-land waterway system ports.

Despite these unique transportation advantages, Blackwell has, in recent years, seen a decline in its industrial base, its population, and its economic outlook. To assist getting this economy back on track, EDA awarded \$750,000 to the Blackwell Industrial Authority and the City of Blackwell in May 2012 to help construct a trans-load facility in the Blackwell Industrial Park. Grantees expect that this project will create or save about 80 jobs. Additionally, this investment will help position Blackwell as an even more ideal location for a warehouse/distribution or time-sensitive manufacturing business.

Oregon

During FY 2012, EDA awarded 23 grants totaling \$4.1 million throughout the State of Oregon. These investments encourage the growth of advanced and metals materials manufacturing, trade, tourism, and disaster resiliency in the state by supporting regionally-owned economic development initiatives to create jobs and position Oregon communities to maximize their economic assets and potential.

Investment Spotlight: EDA Investment links Businesses to Capital for Growth and Expansion

The Mid-Columbia Economic Development District (MCEDD) is a two-state, mostly rural district east of Portland, encompassing Hood River, Wasco, and Sherman counties in Oregon and Klickitat and Skamania counties in Washington State. Four of the five counties are within the Columbia River Gorge National Scenic Area. MCEDD utilizes the differences and leverages the unique assets provided by each state in supporting economic development efforts of the region, including assistance to local businesses.

Many businesses within the district are challenged by the distance between them and entities that provide financing. EDA awarded MCEDD a \$50,000 Technical Assistance grant to implement a web-based fund sourcing tool, the Investment Platform for Economic Development (IPED). IPED will help connect local businesses to capital providers from a variety of geographic areas, so that companies have a better chance of getting the financing needed to expand. In addition, this platform can be replicated with minimal investment throughout other parts of the country to bridge investment gaps and increase economic development opportunities.

Pennsylvania

During FY 2012, EDA awarded 20 grants totaling nearly \$8 million throughout the Commonwealth of Pennsylvania. These investments encourage the growth of manufacturing and heavy construction, entrepreneurship, technology and faith-based economic development. These grants will help both urban and rural communities achieve their local economic development initiatives. These investments are expected to create or retain 1,511 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Expands Business Development in Pittsburgh

Allegheny County, Pennsylvania, is a common case study for the perils of a mono-industrial economic base. When the local steel industry disintegrated in the second half of the 20th century, job losses were monumental. By 2010, Allegheny County had lost one-half of its population due to decades of job loss in the steel and related industries, with half of that loss taking place within Pittsburgh.

In July 2012, EDA awarded a \$1.9 million grant to the Urban Redevelopment Authority (URA) to fund construction of new infrastructure for Bakery Square 2.0, an existing mixed-use development in the East Liberty section of Pittsburgh. This project will expand the abandoned industrial site, a former Nabisco Bakery, which was declared blighted in 2006. This large-scale redevelopment project is part of a \$130 million private-public partnership. EDA's investment funds excavation and installation of new utility lines; grading and build-out of new streets, sidewalks, and curbs; new street lights and traffic signals; and related infrastructure needed to make the site ready for further development. Google accounts for at least 200 high-skilled, highwage positions and has grown since taking residence in Bakery Square. The project is expected to create 530 new jobs and attract private investment of \$49 million, according to grantee estimates.

Puerto Rico

During FY 2012, EDA awarded two grants totaling \$1.7 million in the Commonwealth of Puerto Rico. The University of Puerto Rico through EDA's University Center Program is providing technical assistance and access to the applied research community and other development leaders across the Commonwealth to increase productivity, spur innovation and entrepreneurship, and increase long-term regional competitiveness and economic diversification.

Investment Spotlight: EDA Investment Accelerates Clean Energy Technologies

The Caribbean region is in great need of attracting investment that can create sustainable employment and economic growth. Very limited accessibility to local raw materials, coupled with a high dependence on oil for energy production and transportation, increases the cost of living and operating businesses which deters many domestic and foreign investors to come to the territories.

In FY 2012, EDA invested \$1.6 Million in the Puerto Rico Energy Center at the University of Turabo to fund construction of the Puerto Rico Accelerator for Clean Technologies (ACTech). From its new facility, ACTech will provide tools for entrepreneurs to transform an idea into a marketable product focused on the clean technology sector. ACTech will utilize the expertise of university faculty members and researchers to select projects ready for acceleration. Additionally, clean technology advances will be exported to the other Caribbean islands, such as the Dominican Republic and Haiti. Exporting products, services, and best practices developed at ACTech to other parts of the Caribbean could potentially spur other similar accelerators on other islands.

Rhode Island

During FY 2012, EDA awarded three grants totaling \$2.7 million in the State of Rhode Island. In addition to funding critical infrastructure improvements, EDA invested in a state-wide comprehensive economic development strategy that will bring together the public and private sectors in the creation of an economic development roadmap to diversify and strengthen the state's economy. These investments are expected to create or retain 425 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Expands Opportunities in Offshore Wind

Offshore wind energy presents tremendous opportunities for the U.S. economy. As a clean and sustainable source of energy, offshore wind carries the potential of decreasing the nation's dependence on foreign oil and lowering overall energy costs. Offshore wind also creates possibility for job creation in turbine manufacturing, wind farm construction and maintenance, as well as related industries.

With a waterfront location with accessibility to four modes of transportation (highway, air, water and rail) and proximity to a skilled workforce, Quonset Business Park in North Kingston, Rhode Island, an optimal location for a potential staging area for offshore wind farm development. In FY 2012, EDA invested \$440,000 to construct roadway and utilities improvements to facilitate the expansion of the Park. These improvements will enable the development of 60 additional acres which will position the Park to become a staging area for offshore wind farm development. The Quonset Business Park currently hosts 168 businesses with 7,000 full-time employees and 1,600 part-time employees. With this expansion, grantees estimate the Park support the creation of approximately 275 additional jobs.

South Carolina

During FY 2012, EDA awarded eight investments totaling more than \$14.6 million in the state of South Carolina. These investments support a variety of industry clusters in the state including manufacturing, agriculture, and transportation. The University of South Carolina serves as an EDA-funded University Center which provides resources to develop, implement, and support regional strategies that promote job, creation, the development of high-skilled regional talent pools, and business expansion. These investments are expected to create or retain 949 jobs according to grantee estimates.

South Carolina boasts one of the Rural Job and Innovation Accelerator Competition winners. The Southern Carolina Regional Development Alliance project will create the Nuclear and Advanced Manufacturing Skills Academy in the region comprised of Allendale, Bamberg, Barnwell, Colleton, and Hampton counties.

Investment Spotlight: EDA Investment Constructs Advanced Technology Training Center

In the early 1950s, the United States Atomic Energy Commission constructed the Savannah River Site outside Aiken, South Carolina to produce fuel for thermonuclear weapons. Since that time, the region has become a global leader in nuclear energy. Although none of the site's five nuclear reactors are currently in operation, the Savannah River Site continues to serve as a major job creator in the region, as well as a site of significant research and development in nuclear technology and alternative energy.

To meet the workforce needs of the region's nuclear technology and alternative energy clusters, as well as its growing presence of advanced manufacturers, EDA awarded \$2.6 million to Aiken Technical College and the Aiken County Technical Education Commission to construct the Center for Energy and Advanced Technology. The facility will prepare a highly-skilled workforce in the growing fields of mechatronics, welding, and radiation protection technology. The presence of an educated workforce with advanced skills is critical to continued economic development in western South Carolina. The grantee estimates this project will create 295 jobs and generate \$346 million in private investment.

South Dakota

In FY 2012, EDA awarded 13 projects in South Dakota totaling \$1.7 million. These EDA investments build upon the State's strong history of agricultural innovation and help native communities achieve their bottom-up, regionally-owned economic development initiatives to create jobs and maximize their economic assets and potential. South Dakota State University also serves as an EDA-supported University Center, providing technical assistance primarily for the applied technology economic sectors in the State.

Investment Spotlight: EDA Investment Spurs Innovation in Aquaculture and Alternative Biofuels Clusters

Population loss in rural areas of the Plains states threatens the viability of communities and the critical services they provide citizens of the region. This is especially true for areas largely dependent upon production and shipment of bulk agricultural commodities. As a solution, many agricultural-dominated rural regions are finding that sustained economic growth, higher-paying jobs and new investment can come from nurturing a presence of industries that undertake value-added production of agricultural commodities and byproducts.

In July 2012, EDA announced a \$1.2 million award to the City of Brookings and Brookings Economic Development Corporation to construct the Agriculture Technology Center for Rural Enterprise in the Telkamp Industrial Park. The Center will house pilot scale validation projects to commercialize public and private sector research and provide a broad range of commercialization services to small and medium-sized businesses and entrepreneurs. Designed to bridge the gap between research at South Dakota State University and business development, the Center will focus on advancing the region's growing aquaculture and alternative biofuels clusters. Initial tenants in the Center include a biofuels program that uses bacteria to convert waste products in ethanol plants into valuable fuels and a program that uses soybeans in the manufacture of foods for tank- and pond-grown fish. The project is expected to generate nearly \$3 million in private investment.

Tennessee

EDA awarded 24 grants totaling \$21 million in the State of Tennessee in FY 2012. These investments support the growth of advanced manufacturing in the State, as well as critical infrastructure improvements that will assist the State's ongoing disaster recovery efforts. These investments are expected to create or retain 6,812 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Supports the Next Generation of Manufacturers

With close proximity to the Oak Ridge National Laboratory, eastern Tennessee is a region at the forefront of research and innovation. Through its partnership with EDA, Tech 20/20, a venture development organization based in Oak Ridge, Tennessee, is grooming the next generation of manufacturers who will bring that research to the marketplace.

Tech 20/20 provides training, mentoring, funding, and incubator space to new business start-ups. In 2012, EDA announced Tech 20/20 as a winner of the Advanced Manufacturing and Jobs and Innovation Accelerator Challenge for its proposed project *AMP! - Advanced Manufacturing and Prototype Center of East Tennessee*. At the core of the *AMP!* project are three primary goals: connecting resources to encourage collaboration and expansion of advanced manufacturing jobs; developing a workforce that will drive innovation and expand entrepreneurship; and, innovating and improving manufacturing processes and technologies. Tech 20/20 has already made many important accomplishments to advance these goals. The group has organized R-AMP, the Regional Advanced Manufacturing Prototype Consortium, which is composed of representatives from more than 30 local manufacturers who gather regularly to discuss issues and opportunities in advanced manufacturing. Tech 20/20 is also working to expand robotics competition in the region, aiding with the development of the Smoky Mountain Regional FIRST Robotics Competition, which paired 600 high school students, teachers, mentors, and volunteers, including Oak Ridge National Laboratory researchers.

Texas

During FY 2012, EDA awarded 47 grants totaling approximately \$21.2 million throughout the State of Texas. These investments supported training facilities to help Texans gain new higher-paying employment in fire safety; engineering and science; health care; and industrial technology. According to grantee estimates, the investments in Texas will create or retain 6,144 jobs.

Investment Spotlight: EDA Invests in New Energy Jobs

With an area 400 miles long and 50 miles wide, the Eagle Ford Shale hydrocarbon formation in south Texas could potentially produce billions of barrels of oil and natural gas. First drilled in 2008, the Eagle Ford Shale produced more than 13 million barrels of oil from January to October of 2011 alone. As a result, the State of Texas is experiencing a significant economic boom.

While bringing in significant private investment and jobs, this new drilling has caused substantial disruption to the communities affected who struggle to deal with the economic dynamics of the boom. To assist local communities in South Texas in positioning themselves to take advantage of opportunities resulting from the oil and gas exploration in the Eagle Ford Shale formation, EDA invested \$1 million in September 2012, in the Eagle Ford Shale Community Development Program at the University of Texas at San Antonio. With a focus on strategic planning, leadership training, a regional conference, outreach, and technical assistance programs, communities will be able to diversify their economic base and ensure the long-term sustainability of recent economic gains.

U.S. Virgin Islands

Economic diversity is a keystone to resiliency, and in no place is this principle more evident than in the U.S. Virgin Islands. While the Islands' beautiful beaches make it an ideal tourist destination, U.S. Virgin Islands' officials have long recognized that tourism alone cannot sustain the Islands' economy. The Territory is undergoing an effort in diversifying, strengthening existing and growing new industries. The transformation would assist the Territory in establishing a stable ecosystem.

In order to unlock future opportunities, the Territory will need to be more resilient to natural and economic disasters. The territory is still recovering from two natural disasters, Tropical Storm Otto and Tropical Storm Tomas, back-to-back storms in late 2010 that resulted in mudslides, flooding and landslides. Additionally, in January 2012, an oil refinery that served as the largest private industry employer in the U.S. Virgin Islands announced the abrupt permanent closing of their refinery. The result was the loss of 2,100 full-time workers. Both the direct and indirect the economic impact across the Territory from this closure have been great as the supply chain network supporting the export of the refinery's products has also taken a devastating hit.

EDA has taken a lead role in the Federal government's efforts to help the Territory recover from these economic disasters. EDA chaired the USVI Inter-agency Federal Taskforce's monthly teleconference to discuss strategic planning for upcoming and past federal activities. Coordinated by the Department of Interior's Office of Insular Affairs, this group brings together key representatives from the U.S. Departments of Commerce, Agriculture, Energy, and Transportation, as well as the Small Business Administration and Environmental Protection Agency. Furthermore, with ongoing assistance from EDA, the Territory has undertaken a thorough Comprehensive Economic Development Strategy (CEDS) process that has helped make their economy more resilient. From these planning efforts, EDA has supported local leaders in developing a series of high-impact projects.

Utah

EDA awarded eight grants totaling \$1.4 million in the state of Utah during Fiscal Year 2012. These grants support strategic economic development planning and job creation in the growing information technology industry sector.

Investment Spotlight: EDA Project Boosts Opportunities in Mobile Device Software

While smartphones and tablets have only been on the market for a few years, these devices now dominate IT sales across the country. As demand for handheld computing has skyrocketed, so has the demand for applications, or "apps," that run on them. The software industry is a bright spot in the U.S. economy, as well as a leading American export. Over the past five years, the software industry posted revenue gains in almost every year, and saw employment grow.

In FY 2012, EDA provided \$1 million to the Ogden City Corporation of Ogden, Utah, to help fund the construction of a lab to train workers and provide space for business startups in the growing field of software applications for mobile devices. The initiative is being operated by a consortium of partners that includes the city, WSU, the Weber State University Research Foundation, and private-sector industry leaders. This is a forward-looking partnership to provide mentoring, training, legal services and capital for entrepreneurs, high-tech startups, and small businesses in Ogden. The new lab space will also house a proposed Mobile Apps Accelerator where successful start-up businesses will receive an estimated range of between \$2,400,000 to \$4,600,000 in total in-kind training assistance and angel investment over a 10 year period. The lab is expected to create 750 jobs and generate up to \$4.6 million in private investment over a ten year period, according to grantee estimates.

Vermont

EDA awarded four grants in the state of Vermont in 2012 totaling \$1.5 million. Three of the awards are in response to natural disasters that occurred in 2011 and are designed to minimize economic dislocations resulting from a major disaster by promoting job creation, supporting economic diversification, or fostering disaster resiliency.

Investment Spotlight: EDA Grant Establishes Energy Efficiency Revolving Loan Fund to Assist Small Businesses

As a region, New England has some of the highest energy rates in the country, a fact that is especially true for electricity. These high costs have an acute impact on small and medium-sized businesses that must devote scarce income to energy costs, rather than expand their businesses and create new jobs. While making energy efficiency upgrades to their businesses would significantly lower energy costs, many Vermont small and medium-sized businesses lacked the necessary funds to cover the upfront investments in these improvements.

In order to provide these businesses with opportunities to lower energy costs, EDA awarded \$1 million to the Burlington Electric Department to capitalize and operate an energy efficiency revolving loan fund for to the Department's commercial and industrial users. This revolving loan fund will leverage private to public investments at a rate of 2 to 1 through an on-bill financing model that will help commercial and industrial users overcome the "out-of-pocket" expense barrier for energy efficiency improvements. Each loan is structured so that the customer sees monthly positive cash-flow in energy savings greater than the monthly loan repayment.

This EDA supported revolving loan fund is expected to serve up to 150 businesses within its first three years. Additionally, the upfront costs funded by the loans directly support the local economy, in the form of professional services, skilled trades employment, and equipment and materials purchases.

Virginia

EDA invested \$3.2 million in 15 projects across the state of Virginia during Fiscal Year 2012.

These projects support innovation, entrepreneurship, diversification, and growth in economically distressed areas by supporting the growth of biomedical/biotechnical industries, advanced in agriculture, and commercialization of university research. These investments are expected to create or retain 50 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Creates Statewide Innovation Network

The Commonwealth of Virginia's university system includes many world class research institutions. However, analysis has shown that \$1.1 billion in research funding was not adequately flowing into new start-ups that create jobs.

In 2012, EDA awarded a \$1million i6 Challenge grant to the University of Virginia to establish the Virginia Innovation Partnership (VIP). This project will bring together 10 research universities with \$1.1 billion in annual research activity, five community colleges, 15 corporate partners, and 10 incubators to create a statewide proof-of-concept network focused on selectively moving promising life science technologies and business ideas to commercialization. VIP will attract follow-on public and private research funding that increases technological and economic development in Virginia, leading to new company start-ups, collaborations with existing corporations, and economic growth that creates new jobs which are not easily off-shored or outsourced. In addition to providing access to world-class mentor networks, VIP will give entrepreneurs access to \$10 billion annually in top quartile venture capital partners. Direct job creation across the state is predicted to be 140 jobs over two years, with \$64 million in private investment and 640 jobs created after 4 years, and 2,000 new jobs created after 8 years.

Washington

During FY 2012, EDA awarded 28 grants totaling \$10.7 million throughout the State of Washington. These investments encourage the growth of advanced materials and metals industries, as well as entrepreneurship, research, and disaster resiliency. The State has a focus on cutting-edge technologies and its application to other industries, including advanced manufacturing, as evidenced by several of these awards, including the Jobs Innovation Accelerator award to the Columbia River Economic Development Council. These investments alone are projected to create or retain 930 jobs according to grantee estimates.

Investment Spotlight: EDA Investment Creates Jobs on Tribal Lands

The Tulalip Tribes consist of thirteen Indian tribes and bands which inhabit the area of the reservation that was created by the 1855 Treaty of Point Elliott. The Tribes are longtime recipients of EDA partnership planning funds, which they have used to create and update their Comprehensive Economic Development Strategies (CEDS). With a traditional fishing-based economy, the Tribes sought to diversify their economy starting in the 1990s. Guided by their CEDS, the Tribes focused on 2,000 acres they own along Interstate 5, about 40 minutes north of Seattle and 80 minutes south of the Canadian border, as a tourism destination development. Over the last 20 years, the Tribes have developed Quil Ceda Village, the first federally-recognized tribal city in the country. This development includes Seattle Premium Outlets, with 110 stores, as well as big box retailers, restaurants and specialty businesses. Building on this growth, the Tribes also developed Tulalip Resort, which includes a four-star hotel, and the Tulalip Amphitheater.

While this growth has created significant employment opportunities for the Reservations, the Tribes constantly reevaluate their needs and opportunities through the ongoing CEDS process. As a result, the Tribes coordinated to create Tulalip Broadband and Tulalip Data Services which offer technology services to Tribal members and businesses looking to locate near tribal lands. All of these businesses have brought jobs and income both to Tribal members and the surrounding community and serve as a strong example of how long-term, coordinated economic development planning can lead to increased prosperity.

Wisconsin

During FY 2012, EDA awarded 10 grants totaling \$2.69 million in the State of Wisconsin. These investments spurred job creation in agribusiness, food production, water-based technologies, automotive technologies, and high tech manufacturing. These projects leveraged the assets of the rural areas and the states university and community college system to create a holistic approach to economic development that is able to increase productivity, spur innovation and entrepreneurship, and increase long-term regional competitiveness and economic diversification.

Investment Spotlight: EDA Investment Promotes Innovation to Increase Exports

Building on the state's tradition as the "Dairy State," dairy products remain a significant portion of Wisconsin's economy. Dairy production is especially critical in the state's rural areas as most dairy business manufacturing facilities are located in small communities with a population under 5,000. Expansion of the value-added dairy industry through new or expanding cheese and whey manufacturing businesses strengthens rural ecosystems and helps stabilize economic drivers in small communities.

In FY 2012, EDA announced the Wisconsin Innovates for Success (WINS) Proof of Concept Center as a winner of its i6 Competition. Focused on commercialization of dairy-based university research, the WINS program provides entrepreneurial and innovator support to launch new food products, expand dairy plants, or create startups. The public/private partnership, led by the Center for Dairy Research (CDR) at the University of Wisconsin-Madison, facilitates and fosters ideas between technical and business partners, higher education, not-for-profit organizations, export groups, and trade associations representing the dairy industry. The University has identified three key goals for this project which will have major economic impact: to make the U.S. the leading exporter of cheese to Asia by developing new products specifically designed to meet the needs of China/Asian markets; to grow U.S. whey exports by converting all cheese and by-products into valued-added, nutritious ingredients; and to find healthier cheese alternatives for school menus. The commercialization of this innovation is anticipated to generate \$15 million in private investment and create an estimated 200 jobs in Wisconsin communities.

West Virginia

EDA made 14 awards totaling \$1.8 million across the State of West Virginia in FY 2012. These included annual planning grants, a University Center, and two Jobs and Innovation Accelerators. By supporting bottom- up, regionally-owned economic development initiatives, EDA's investments will create jobs and position West Virginia communities to maximize their economic assets and potential.

Investment Spotlight: EDA Award Broadens Existing University Partnership to Create Workforce Development Opportunities

Building upon their existing EDA University Center collaboration, Marshall University and Concord University again joined forces in 2012 as a winner of EDA's Rural Jobs Accelerator Challenge. EDA invested \$435,000 to assist the universities in establishing the Southern West Virginia Rural Jobs Accelerator Partnership. This partnership leverages regional resources to create workforce development opportunities -- including skills training, e-business opportunities, grant-writing and entrepreneurial workshops, and access to capital investment consulting -- to advanced manufacturing and tourism businesses across southern West Virginia. By building business knowledge and workforce skills across the region, the project will entice investors to the region, stimulate the creation of new companies, improve worker performance, enhance the region's online presence, and serve as a model for similar communities across the country.

Within the first year, the Accelerator program has supported eight projects which have created 12 new jobs and saved 309 existing ones. These investments are encouraging the growth of advanced manufacturing and tourism in the state and support the aeronautics, energy and high technology industry clusters.


Wyoming

EDA made four awards totaling \$382,455 during FY 2012 across the state of Wyoming. These investments support the development and maintenance of Comprehensive Economic Development Strategies (CEDS) that provide a roadmap for long term economic growth and the operations of a university center at the University of Wyoming in Laramie. Collectively, these investments will help position communities in Wyoming to maximize their economic assets and potential.

Investment Spotlight: EDA-Supported University Center Develops Early Stage Tech Companies

Through EDA's University Center Program, the Wyoming Technology Business Center (WTBC) expanded business incubation and outreach efforts during 2012. Opened in 2006 and located on the campus of the University of Wyoming in Laramie, the 30,000 square-foot facility offers laboratory, office, and shared conference room space for client companies as well as collocation space in a state-of-the-art data center.

The WTBC focuses on developing early stage, technology-based companies, with an emphasis on high-growth firms. All client companies located in the incubator have access to one-on-one business counseling and executive coaching services provided by the WTBC staff. Statewide networking opportunities are available through an educational networking group called e2e Wyoming. The program is designed to help client companies grow larger and faster than they would otherwise, and to increase the ability of the entrepreneurs to grow and manage their own businesses.

EDA Leveraging Goals for Private Sector

Section 603(b)(2) of the Public Works and Economic Development Act of 1965, as amended, requires EDA to include in its Annual Report to Congress a discussion of private sector leveraging goals set for investments awarded to (a) rural* and urban economically distressed areas; and (b) highly distressed areas.**

The following information is provided to respond to those requirements.***

(a) EDA's private sector leveraging goal with respect to grants awarded to rural and urban economically distressed areas:

EDA has consistently shown sound results in attracting private capital investment in both rural and urban distressed communities. In FY 2012, EDA invested 62% of its infrastructure and RLF funds in rural areas which grantees expect will leverage \$2 billion in private investment; 38% of the funds were invested in urban areas which grantees expect will leverage \$2.6 billion in private investment.

(b) EDA's private sector leveraging goal with respect to grants awarded to highly distressed areas:

EDA recognizes that importance of private capital investment for successful economic development and recognizes that importance of maintaining significant flexibility to assist those communities that are taking the first steps toward economic growth. Therefore, EDA often makes prudent investments in areas where leverage ratios are lowest.

In FY 2012, EDA invested 47.8% of all its funds in highly distressed areas which grantees estimate will generate \$1.5 billion in private investment.

**For an area to qualify as being highly distressed, one of the following criteria must be met: (a) a 24 month unemployment rate of at least 200 percent of the national average, (b) per capita income not more than 60 percent of the national average, or (c) a catastrophic disaster.

***U.S. Department of Defense reimbursable investments and disaster supplemental investments are not included in these calculations.
